MONDAY, March 28.

TILBURY CENTRE.

On the report of the Private Bills Committee being read,

Mr. MEREDITH said that he observed the bill to incorporate the Village of Tilbury He understood the arrangement made in the House to be that this bill would not be reported without everybody interested

having an opportunity to be heard.

It was explained by Mr. GIBSON (Hamilton), Chairman of the Private Bills Committee, that the question was asked whether all parties had been notified of the bill coming up, and he understood nobody had any objection to the bill going through, and by Mr. Balfour, that I he had visited his constituency and explained the position, and the provisions of the bill as introduced had been by a public meeting, no person jecting. Mr. Meredith, however, said there was a question involved respecting the enforcement of the Scott Act, and there might be some outside the village who would object to something in the present bill. At the suggestion of the Attorney-General, the bill was ordered to stand, Mr. Balfour concurring, and stating that he would be glad to allow the measure to stand for a week, so that all interested might be heard.

JUSTICES OF THE PEACE, ETC.

Mr. MONK presented a bill to disqualify barristers, attorneys, solicitors and doctors at law from being justices of the peace, stipendiary magistrates or police magistrates. bill was read the first time.

THE TORRENS SYSTEM.
