to the servant, and the same are not paid within the time limited by the order, similar proceedings can be taken by the servant to enforce the order of the magistrate as is

provided for in the Division Court Act. ROAD COMPANIES.

Dr. McMahon's amendment to the Road Companies Bill proposes to reach parties owning roads which they purchased from the Government.
