COUNTY BRIDGES Mr. Meredith has a bill before the House in which it is provided that when there is a dispute between the County Council and the Council of any other municipality, as to which municipality is liable for the building or maintaining of a bridge, either party to the dispute may prosecute an action in the High Court of Justice to try the question of dispute. It is also provided that the Court may compel by mandamus the performance of the duty or liability of the municipality. THE AID TO THE UNIVERSITY. Mr. Ross (Huron) has given notice of the folowing motion :-"That the following resolutions, together with the message of His Honor the Lieutenant-Governor on the same subject, be referred to a Committee of the Whole on Thursday next :-"Resolved, that a sum not exceeding one hundred and sixty thousand dollars be set apart, from and out of the surplus moneys forming part of the Consolidated Revenue Fund of this Province, to aid in the reconstruction of so much of the buildings of the Provincial University, otherwise known as the University of Toronto and University College, as has been injured or destroyed by fire. "That all moneys receivable or recovered by or on behalf of the said Provincial University. under any policies of insurance effected against loss or damage by fire to the University buildings, and which moneys are estimated as amounting to ninety thousand dollars, shall first be paid out and fully expended for and on account of the said reconstruction; and thereafter only so much of the said one hundred and sixty thousand dollars as may be necessary to secure the completion of said reconstruction shall, from time to time and as the work progresses, be paid in such sum or sums as, by order of the Lieutenant-Governor in Council. may be authorised and directed in that behalf.
