RECENT UNIVERSITY CALAMITY.

Generous Donation of the Sister Province Recognised—Houses of Refuge and Mining Laws—Liquor License Legislation.

The proceedings of the last session of the Sixth Legislature of Ontario formally terminated yesterday afternoon. C Company was on hand, under command of Major Vidal. Lieuts. Laurie and Evans and Bugle-major Fortier supported the Major. Other military men present were Col. Greville Harston, A. D. C.; Commander Lawe, Secretary to the Lieutenant-Governor; Col. Grey and Col. Dawson. There was a sprinkling of members, ladies and prominent citizens, among the latter were Mr. Justice Maclellan and Very Rev. Vicar-General Rooney. The ladies included Mrs. Mowat, Mrs. A. M. Ross and Mrs. Baxter. The members included the Attorney-General, the Treasurer, the Minister of Education and the Provincial Secretary, representing the Government, and of the private members Mr. Meredith, Mr. Creighton, Mr. H. E. Clarke, Mr. Craig, Mr. Monk, Mr. Smith (Frontenac), and Dr. Gilmour, Mr. McAndrew, etc., representing the private members on the Liberal side of the House. It was about 3 o'clock when the Lieutenant-Governor entered, accompanied by his Aide-de-Camp and Secretary. The members of the Government named above, the Speaker and the Sergeant-at-Arms followed.
