One of the best and most ably conducted public institutions in the Province is that for the education of the deaf and dumb at Belleville. The annual report furnishes evidence of substantial and satisfactory progress in the training and education of the pupils. When Inspector Chamberlain visited the institution in March last there were 260 pupils in residence, 145 males and 115 females. Everything was found to be in an orderly and satisfactory condition. Reference is made in the report to Mr. R. Matheson's able efforts to promote the work for which the institution is designed.

CARE OF THE INSANE.

In the 24th annual report upon the lunatic and idiot asylums of Ontario, Mr. R. Christie, inspector of prisons and public charties, calls attention to the constantly increasing number of the insane population of the Province, as shown by the returns

from the general institutions.

During the year ending Sept. 30, 1890, there were 666 patients admitted, and for the year under report there were 928, showing an increase of 262. The average daily number of patients in residence also shows an increase of 240, the number for the former year being 3,266 and for the latter 3,506. The numbers remaining in residence at the close of these years respectively were 3,318 and 3,468, being an increase of 150.

Mr. Christie submits some valuable information regarding the care of the insane, which goes to show that the present method has worked satisfactorily both from an economical and philanthropic point of view.
