OTTAWA ASKS FOR LEGISLATION COMPELLING ELECTRIC WIRES TO BE PLACED UNDER-

GROUND-THE SPEAKER'S GUESTS.

In its petition submitted to-day by Mr. Bronson, the City of Ottawa asks that an act should be passed in the public interest by the Local Legislature requiring all telegraph, telephone and similar companies to place their wires underground within a reasonable time after the enacting of such legislation, and that such power should be conferred on municipalities as would enable them to provide conduits in which all electric wires should be placed, and to collect from all companies using the same an amount in each year sufficient to defray the interest and sinking fund upon the cost of such works.
