since then. Mr. Gibson (Hamilton) was aiso opposed to the continuance of the college then. He agreed to vote for the continuance of the college on the understanding that the sum then voted would be a finality. The sum voted had been largely exceeded. He was bound to accept the statement of the Attorney-General that the expenditure was not illegal. But he questioned the morality of it. He concluded that every principle of responsible government as enunciated in the last 50 years had been violated. He would support the amendment moved by Mr. Meredith.

There were cries of "call in the members." The motion to adjourn the debate was withdrawn, and the division on Mr. Meredith's amendment was taken as fol-
