PETITIONS PRESENTED.

The following petitions were presented :-By Mr. White-From ratepayers of Rochester Township, Essex County, asking for the partition of the township. The petition sets forth that the residents in the southern portion of the township do. not get their share of the benefit from the heavy taxes they pay; that most of the Councillors live in the northerly portion of the township, and are interested accordingly; that the township has been engaged in several law suits which concern only the northerly portion, but which has increased the general taxes; and that the roads in the northern portion were opened at the general expense, while those in the south had to be paid for out of a special rate.

Mr. Ross (Middlesex) presented a petition from trustees and ratepayers of school section number five in Westminster Township, Middlesex, asking that the property of the City of London Water Commissioners situate within the limits of the section become liable to taxation for school purposes, from which they are now ex-

empt.

By Mr. Caldwell-Frem a number of steam users of Ottawa City asking an amendment to the act respecting stationary engineers, requiring that persons in charge of a steam plant of over fifteen horsepower be required to obtain a certificate of competency from the Board of Examiners of the Ontario Association of Stationary Engineers.

By Mr. Field-From Mayor Wilson and 134 ratepayers of Cobourg, asking that no taxes be levied on improvements on land, or to grant power to Municipal Councils to carry this petition into effect.

By Mr. White-From the Water Commissioners of Windsor, asking to be allowed to issue debentures to \$500,000, and

for the validation of by-laws under which previous debentures have been issued.

By Mr. Ferguson-From Kent County Council, praying that the law may be altered regarding indigents confined in county gaols, and also asking to have determined the length of time a person has to be a resident before becoming a charge on the municipality. The petitioners, in regard to the first point, ask that the County Judge be given authority to order the removal of any aged or sick vagrant in counties where there is no House of Industry to some suitable institution, and asking also that the practice of municipalities giving railway passes from one station to another to such vagrants be declared illegal.
