HE FIRST THIRD READING.

Half a Dozen Bills Advanced a Stage.

Batch of Bills Promised by the Attorney-General - A Twenty-Minute Sitting.

Monday, March 9.

The private members to-day lost many opportunities for advancing their bills a stage. There was a very slim attendance, and the House went through the entire order paper with no greater results than one third readand half a dozen second readings. after bill was called; only to be as its promoter was not present. House, consequently, had finished the work which it could do in renty minutes, and had nothing to do ut adjourn. At the opening of the House Sir

Oliver Mowat moved that the name of Mr. Matheson be added to the select committee chaving the control and management of the library. The Premier also introduced a bill respecting bills of sale and chattel mortgages n unorganized districts.

Hon Mr. Gibson laid on the table a copy of the agreement between the Government and the City of Hamilton respecting the removal to that city of

the School of Pedagogy. The terms of this agreement, which are highly satisfactory, have already been published.

BILLS ADVANCED.

The first third reading of the session followed; it was Mr. Crawford's bill respecting the Hospital for Sick Children, and it went through the final stage, the only change being the addition of the words "at Toronto" to the title.

The following private bills were read a second time:-

Mr. Harty-Respecting the Roman Catholic episcopal corporation of the Diocese of Kingston.

Mr. Truax-To confirm by-law No. 486 of the Town of Walkerton.

Mr. Middleton-Respecting by-laws Nos. 680, 792 and 823 of the City of Hamilton.

Mr. Flatt-Respecting the jail of the County of Wentworth.

Mr. Middleton-Respecting St. Thomas' Churca, Hamilton.

In reply to a question by Mr. Little, Hon. Mr. Gibson said he was not aware that the two chaplains in the Penetanguishene Reformatory ngaged in any outside work other an in connection with their duties in institution.

r. Mutrie's bill providing that unty Councils may grant aid to ds in township municipalities which municate with county roads was ven its second reading.

The House adjourned at 3.40.

BILLS INTRODUCED.

Sir Oliver Mowat's bill respecting bills of sale and chattel mortgages in unorganized districts provides for the registration within ten days after the execution of bills of sale and chattel mortgages in Muskoka and Parry Sound with the Deputy Clerk of the District Court at Bracebridge and with the Clerk of the District Court at Parry Sound. The act takes effect on September 1, 1896.

Mr. Marter has introduced a bill to mend the drainage act, 1894. It deals ith the operation of drainage works y commissioners where pumping or

other machinery is used.

Mr. Taylor's bill to amend the muniipal act repeals the provision of the nunicipal act, inserted in 1894, requirig notice in writing of an accident to given one in 71th after its occurence to the Clerk of the municipality fore an action can be brought for

TWO DEPUTATIONS.

A deputation from the Toronto Collegiate Institute Board, composed of Mr. T. A. Hastings, ex-Ald. Oliver and Dr. John Ferguson, waited upon Hon. Geo. W. Ross this morning with reference to the High School bill now pending. They suggested several amendments looking towards the group ing of the Toronto . Collegiate Institutes, so as to permit specialization of work on their parts. They also made some suggestions as to the teaching of drill, saying that it is useless as at present taught, and suggesting that there might be fifteen minutes per day of physical exercise. The Minister promised to consider the suggestions made.

A deputation of members of the Commercial Travellers' Association, headed by Mr. R. L. Patterson, waited upon the Provincial Secretary today, asking for certain concessions as to the registration of the agents of their accident insurance society.
