MR. NOXON.

Mr. Whitney asked :- Is James Noxon still In the service of the Government as Inspector of Prisons or otherwise? Is he also In the service of the Government of Canada, and if so, in what capacity? At what date did he enter into the service of the Government of Canada? Has he received his salary from the Ontario Government since said date, and who has since said date performed his duties as Inspector of Prisons ?

Mr. Davis replied :-- Mr. Noxon is still in the service of the Government as Inspector of Prisons. He was by commission temporarily appointed by the Dominion Government to make a special examination into the affairs of Kingston Penitentiary, owing to his special knowledge relating to the management of public and penal institutions. He has served thirty-one days upon the commission, most of which time was during the three weeks' leave of absence allowed to public servants as an annual vacation. He has been in receipt of his salary from the Ontario Government, and has continued to perform his duties as Inspector of Prisons, excepting during his occasional absence on the commission. At the time of his appointment it was understood that an abatement should be made in his salary from the Province during the time of his absence, except as to the three weeks' vacation referred to.

MR. PRESTON'S CASE.

The leader of the Opposition also asked: -Was W. T. R. Preston, now Librarian of this House, a candidate for the representation of the electoral district of West Toronto in the House of Commons of Canada at the general election of June, 1896? If so, did he resign his position as Librarian, and on what date? Was any promise given, or understanding arrived at, with the said W. T. R. Preston, that, in the event of his defeat at sald election, he should be re-appointed Librarian? Was he re-appointed Librarian, and if so, on what date ?

The Premier replied :-- Mr. Preston was a candidate. He resigned his position as Labrarian on the 16th of June.
