A FRUITFUL SESSION.

Legislature Duly Thanked and Formally Prorogued.

RECORD OF THE SESSION.

The contrast between the opening and closing of Parliament was never more marked than this session. Two months ago when his Honor the Administrator entered the buildings he was surrounded by a brilliant staff and was received by perhaps the most brilliant assemblage ever seen in Toronto. Yesterday his Honor drove up and prorogued the House, but his arrival did not cause much more excitement than that of a midsummer tallyhe party, and not half so much as a full-grown temperance deputation. The weather was depressing in the extreme and very few spectators were present. When the House opened at 2.30 o'clock there was not a hundred persons present, including the members. A few ladies occupied seats on the floor of the House and the galleries were not altogether vacant. The Speaker opened the House with the usual prayers, which he read in the impressive manner which has so frequently been remarked by visitors to the House this session. The Premier then presented a petition in favor of the Simcoe monument. Then he rather surprised the House by presenting the sixth report of the Municipal Committee, which had been overlooked in the crush. It dealt with Mr. Howland's arbitration bill, and the bill was immediately given all the touches requisite to "crystalize it into legislation," as Mr. Haycock would say. Then there was a dull pause, and an effort was made to cheer things up by turning on the brilliant array of electric lights and closing the curtains to shut out the fog and the rain, but the gloom was not a together relieved. After a while his Honor was seen saying, "How do you do ?" to the Premier, and the House rose to its feet. The Administrator, who wore a black coat with the insignia of three orders on his breast, ascended the Speaker's throne.
