ture has already gone in order to obtain the desired accuracy in their financial affairs. However, he has no doubt that the new books will pave the way for great improvements in municipal bookkeeping.

The Cause of Labor.

A deputation, representing the Executive Committee of the Trades Congress of the Dominion which met in Hamilton in September last, waited upon the Government to-night and made four requests, the granting of which they claim will advance the interests of

labor. It was composed of Messrs. D. A. Carey, President; Geo. W. Dower, Secretary; John Flett and Charles March. The deputation was accompanied by Mr. Middleton of Hamilton. The Government in the first place were urged to appoint local factory inspectors in such cities as Hamilton so as to obviate the necessity of sending an inspector from Toronto when occasion arises. The second request was that in order to better secure the secrecy of the ballot the number should be removed therefrom. The third proposal is that the Government shall include in its trades-mark legislation the union label, following in this respect the example of the Dominion Government. Finally the deputation entered a protest against the two-acre farm land exemptions in cities.
