An amendment was made to Mr. Hardy's bill to amend the election act, striking out Harold Lake and Sturgeon Falls from the list of polling places in West Algoma, and transferring a small strip of territory in the Thunder Bay district, in which there are practically no votes, from East to West Algoma. It was also provided that the last municipal voters' list shall be the list for Provincial purposes on Manitoulin Island. This has been made necessary by the inability of the Judge to get over to the island before the 20th and the possibility of an early dissolution.

Patent Medicines.

The House went into committee upon the bill respecting the sale of patent and other medicines and of alcohol for the purposes of arts and manufactures. The Attorney-General explained the changes proposed by the bill. The bill was passed through committee and stands for third reading. As it now stands it provides that chemists and merchants who deal in patent or proprietary medicines may sell any or proprietary medicine patent and unbroken in the original package, which contains only sufficient alcohol to hold the medicina! constituents thereof in solution or to prevent fermentation. Chemists may also sell tinctures, fluid extracts, essences, medicated spirits or perfumes containing alcohol and prepared according to any recognized standard work on pharmacy, and when in original packages the same may also be sold by merchants dealing in drugs and medicines than in a city. The elsewhere sale of drugs and medicines containing alcohol by a chemist for strictly medicinal purposes is confined to a quantity which does not exceed six ounces of alcohel, and an exception is made in cases, of emergency arising from the serious injury or fainting of any person who may be brought or shall come into a drug store, or in the immediate neighborhood, in which case a druggist may sell not more than six ounces of liquor without the medical certificate required by the liquor license act. Chemists or merchants who keep patent or proprietary medicines for sale are required to allow any officer of the
