(9) Where a company or corporation is, rotwithstanding the pharmacy act or this act or any other law, entitled to sell drugs, medicines or poisons, or compounds or preparations thereof, when such sale is personally conducted by a duly qualified and registered chemist, such sale shall not be an offence against the liquor license act where the crugs, medicines, poisons, compounds or preparation thereof are mixed with alcohol, if the provisions of this act and the restrictions thereby imposed are observed and conformed to upon such sale. But this section shall neither enlarge nor diminish the rights of a corporation to sell the articles aforesaid, except as to the article of alcohol.

shall authorize any person to act as a chemist or to compound prescriptions or to sell drugs and medicines heretofore prohibited from so doing by the pharmacy act, nor shall anything in this act contained prohibit any person from so doing who was not heretofore so prohibited by the pharmacy act or otherwise by law, but the said pharmacy act shall not be affected by this
