## May Establish Potteries.

The Bureau of Mines has received a communication from an American pottery firm, stating that if they can obtain the raw materials they will probably establish potteries in Ocianio. The necessary malerials are a pure silica either white quartz sand or something similar, felspar and kaolin (alumina). There is lots of felspar in Ontario. Silica is also probably to be found in good quantities, and kaolin, it is thought, can also be found. Any person who knows of the existence of silica or kaolin should communicate the fact to the Bureau of Mines.

## Report on Standing Committees.

In submiting the report of the Committee on Standing Committees, Mr. Gibson said that the committee decided in favor of reducing the size of some of the standing committees.
