Mr. Reed again insisted that he had not made any such reference.

"Is 'Sheeny' Jew or Gentile?" queried Mr. Reed.

"I think the hon, members on this side of the House and the Speaker will bear me out when I say that the words I used were those I have said I used," continued Mr. Reed. "I had no idea at the time that there was any misunderstanding upon the part of the gentlemen opposite, and if either the Attorney-General or the member for South Wentworth objected then, I did not hear them." And there the incident closed.

Premier Whitney then arose and stated that as there was little probability of getting through with the Budget debate without a session to-night. he would move an adjournment until 2.30 o'clock. The Government had expected to conclude at 6 o'clock to-

night.
