Buffalo Saturday night or Sunday." Glassco was the man interested in the charter.

Apparently nothing resulted from the trip, witness told Mr. Elliott. He understood the price that Glassco was asking was not acceptable to Browne.

# The Meeting at Buffalo.

Mr. White stated that at the meeting in Buffalo Glassco and Browne were talking and afterwards Browns asked about the Devonshire track, and he (witness) told him that that was under litigation.

Mr. Elliott-Did you know whether as a matter of fact Browne had bought that Devonshire charter Mr. White-No. I do not know.

### Denics Any Gifts.

Mr. Elliott-Have you any stock or personal interest in this

Mr. White-I have no stock in any

racetrack.

Mr. Elliott-Who paid your expenses to Buffalo?

Mr. White-Myself personally. In reply to Mr. Sinclair (South Oxford) witness said he had received nothing from Browne or Dr. Reaume. No expenses of any kind relating to the matters mentioned had been charged to the department. Mr Browne had asked him to go to Detroit, but he said he was through. He did not want anything out of the business or any promises of anything.

#### Increasing Tax on Tracks.

Mr. White was also question as to the increased tax on the racetracks in the Province. He thought the Ontario Jockey Club had invited him down to find how much the jockey clubs could stand in the way of taxation. That information was confidential. He thought it was Mr. W. N. Ferguson who told him he could go and see the books. Mr. Ferguson then belonged to the firm of Millar, Ferguson & Hunter. Mr. Elliott said Mr. Ferguson was a member of the firm Mr. White formerly belonged to, but Chairman McCrea ruled a question on this point out of order.

Mr. Elliott-As a result of your investigations a rate was fixed for the

racetracks?

Mr. White-A rate was fixed for the racetracks. I do not know how it was arrived at.

## Dr. Reaume's Interest.

Dr. Reaume, former Minister of Public Works, in the course of his evidence, said, "Mr. Glassco had some doubts as to the validity of his charter and consulted me. I did not know whether his charter was alive or not. I told him when I went to Toronto I would find out. I called on Mr. Hanna, but he was out of the buildings. I then went to Mr. Armstrong, who thought as far as he knew that it was all right. Mr. Elliott-Which charter are you

# Getting a Purchaser.

Dr. Reaume -- To the Glassco charter, the Windsor Athletic and Racing Club. Mr. Armstrong advised me to call on Mr. White of the Treasury Department. Mr. White told me there were some parties in New York looking for a charter. I do not think he told me who it was. I said: If you let us know I will communicate with Mr. Glassco and as a fellow-townsman of mine, give him an opportunity of dealing with this gentleman at New York. Shortly afterwards I think I got some communication to go and meet Mr. Browne some place in New York. I took that communication and handed it over to Mr. Glassco and said, "Here's a prospective purchaser for your charter, and a request to go and meet him in New York." He (Dr. Reaume) had made it clear he was not going. Afterwards he got some correspondence as to the value of the charter. He consulted Mr. Glassco as to what he wanted. Some days he wanted \$50,000, and then he made it \$75,000.

# Holds Stock in Track.

In reply to Mr. Sinclair, Dr. Reaume stated he had interests to the exeent of \$1,000 in the Devonshire track, for which he paid. There was no bonus or present. He never received any bonus or commission. He had \$1,000 in the Windsor Driving Park. "I admit I am a little fond of a horse race," said the former Minister of Public Works, "and manifest my interest in taking a little stock."

# White's Connection With Windsor Deal
