#### J. W. CURRY IS INCLUDED

The committee of the members of the Legislature to investigate and report on the working of the Ontario Temperance Act, following the present session, was named by Premier Drury in the House yesterday. The committee has power to report as to improvements in the act and in its administration.

J. W. Curry (Southeast Toronto), when the names had been read, wanted to know why his name was not on it. The Premier replied that he had nothing to do with it, as the party leaders had suggested the names. He thought, however, Mr. Curry should be on the committee, and added his name with that of R. M. Warren (North Renfrew).

# FIRST SESSION OF NEW HOUSE COMES TO END

Ontario Legislature Adjourns at Ten Minutes Before Midnight

#### ROLLO'S BILL WAS LAST

### Corrects Technical Error in Amendments to Compensation Act

The first session of the fifteenth Legislative Assembly of Ontario concluded ten minutes before midnight last night. The last item of business was the passage through three readings of a measure introduced by Hon. Waiter Rollo to correct a technical error in the amendments to the Workmen's Compensation Act. Members then stood in their places and concluded with "God Save the King."

In many respects the session just concluded is among the most notable of the sittings of the Ontario Legislature. A group of farmers, inexperienced in Government affairs and Parliamentary procedure, undertook to enact and pilot through political highways and byways important laws affecting the banner Province of the Dominion. They succeeded to a degree beyond the hopes and expectations of the people.

#### Many Important Acts.

Outstanding among their enactments was the legislation fathered by the Labor group. Mothers' pensions have come to brighten the lot of many of the Province's women and children, and workmen's compensation rates have been advanced. Minimum wages for female workers is still another bright page in the book of bills. The way has also been paved for a clean-up on the drink evil, and as a result of two measures passed Ontarto may be "bone dry" when the Legislature next sits.

There were but forty or forty-five members in the House when the end came. Last night's close was a complete surprise. A Saturday sitting had even been arranged for. But members were anxious to get back to private affairs, and by general consent the passage of last-minute Hydro and other legislation was facilitated.

Adjournment was officially announced until Friday, June 4, when the official concluding ceremonies will be performed.

#### Praise for the Speaker.

Before adjournment of the Ontario Legislature last night the members enthusiastically expressed unanimous concurrence in Premier Drury's motion expressive of appreciation of the services of Speaker Nelson Parliament. Premier Drury applauded the Speaker's rulings as eminently fair and eminently just. From every corner of the House members arose and expressed their concurrence in the laudatory references of Premier Drury, and heartily applauded the motion as it was carried.
