SINCLAIR IN DOUBT THAT GASOLINE TAX CAN BE COLLECTED

Maintains That Government Has No Definite Legal Method

BILL NOW IN LAST STAGE

Shashing criticism of Governmental reticence in giving details as to how it was going to collect its three-centa-gallon tax on gasoline, followed by sarcastic comment which made Treasury-bench occupants wince when the Premier said that the Government still was studying this matter, were the means by which Liberal Leader Sinclair livened a somewhat dull committee debate in the Legislature yesterday afternoon.

impromptu effort this session and he roused his followers to much desk hammering. The incident began when Zotique Mageau (Liberal, Sturgeon Falls) argued that with a gasoline tax there should be a graded license fee for motor cars; that the man who ran his car only four or five months in the year should not have to pay the same license fee as the person who ran his car 12 months of the year. Mr. Sinclair backed up this claim, and declared that the present method, the basis of the present tax, was absolutely unsound, unfair, and indefensible. Mr. Sinclair then demanded that the Government say where the con-

sumer was going to pay the gasoline tax. Would it be at the gasoline station? Unless the tax were payable there the act was unconstitutional. "The Government won't tell us." I think this bill should not be allowed to pass the committee stage until the Government tells us."

"I am delighted to know from the Prime Minister that they don't know how they are going to collect the tax," said Mr. Sinclair.
