School Insurance.

A bill respecting the Board of Education of Toronto, introduced by A. R. Nesbitt (Con., Toronto N.W.), provides for a special grading of insurance rates for the schools in the city. Between 1898 and 1925 the amounts paid in insurance exceeded the money received in claims by \$165,315. It is noted that Toronto has built up a strong fire fighting system, and that the fire risks in Toronto schools and property, valued at \$22,020,000, are apparently less than in other buildings, and so the bill proposed a grading of insurance to take all this into consideration and lower the rates on the schools. Mr. Nesbitt also sponsored the bill to provide for a gas audit in Toronto.

Measure Is Introduced To Amend United Church Act

An act to amend the United Church of Canada Act was introduced for first reading by Alexander Lewis (Conservative, Toronto), who explained the aims of the measure to the House. Under the present act a congregation which delayed too long in taking its vote automatically passed into Union. The amendment is designed to give certain congregations which looked upon this automatic action as a hardship the right to take another vote under the supervision of the Church Property Commission. By this measure the same Commission will be empowered to right grievances instead of merely recommending settlement as has been the case in the past.

NOMINATE COMMITTEE TO DISPOSE OF FUND

Suggestion Is Made to Have Every Canadian Unit Represented

A deputation of returned soldiers representing unattached veterans presented to Provincial Treasurer Price yesterday, their views concerning the disposition of Ontario's share of the canteen fund, being the recommendations of the veterans' meetings held on Tuesday night. They urged that Col. Price himself, with Captain Norman Lambert and Gen. V. A. S. Williams, be the three soldier administrators on the Provin-

cial Committee to disburse the fund. George Moore, prominent in soldier circles, conferred with the Provincial Treasurer on Tuesday, advocating the appointment of two representatives from every military unit which went overseas as delegates to a central meeting, from which a choice of four members to the Canteen Fund Distribution Committee could be made. The fifth member and Chairman of the committee should be appointed by the Government, Mr. Moore told Col. Price.
