COMMITTEE REPORTS ODDFELLOWS BILL

Seeks Reincorporation Relief Association of Order

The Private Bills Committee of the Legislature yesterday reported without amendment Colonel T. Ashmore Kidd's bill that seeks reincorporation of the Oddfellows' Relief Association under the name of the Mutual Relief Life Insurance Company.

Committee approval of the measure was vigorously opposed by R. L. Honeyford, who claimed that the great majority of the 18,000 members of the association really had no opportunity of opposing the decision of a special committee to drop the fraternal insurance idea for the mutual system.

Proponents of the measure held that it was absolutely necessary that the association branch out into a mutual

company.

It was also explained that, notwithstanding a reporting of the bill by the committee, the mutual insurance arrangement could not become operative without a two-thirds vote of the association membership. Committee finally approved of the principle by a vote of 17 to 10.

NEW BILL PROVIDES Mednesday. Feb. 2774 FOR HEAVIER LOADS OVER CERTAIN ROADS

Highways Will Be Rated 'A' Class and 'B' Class for Trucks

MOMENT OF MERRIMENT

The Ontario Government is extending to big truck owners the opportunity of carrying heavier loads of truck tonnage over certain roads of the Province.

It proposed to allow the gross load of weight carried on certain roadbeds to be raised from the present eight tons to ten tons. And to meet this situation of increased tonnage, it will split the roads into two groups, namely A class and B. Class.

Henry's Amendment.

This Hon. George S. Henry, Minister of Highways, made known in the House vesterday, when he introduced a amendment to the Highway Traffic Act embodying this new plan. He stated that the amendment involved several changes, but that this one was the most important.

Premier Ferguson yesterday introduced an amendment to the Parents' _ Maintenance Act, which "cures an oversight" in the present act. Under existing legislation dependent parents may make application for support by their children, but such rights are not extended to parents in institutions. The amendment enables the head of an institution or trustee to make such application on their behalf.

A score of private bills were brought down yesterday, one in particular creating a moment of merriment in the

House.
