In the event of the incapacity of any pensioner, or if the central Commission considers that the pensioner is using, or is likely to use his pension otherwise than for his own benefit, the Commission may direct the payment of the pension to a trustee or trustees approved by the Commission, to be expended for the benefit of the pensioner.

#### Not to Be Disfranchised.

The Commission may, with the consent of the pensioner, assume the management of any property, real or personal, belonging to the pensioner. The receipt of a pension shall not by itself disqualify any person from voting at any Provincial or municipal election.

The wide powers given the administering Commission under the act are further reflected in the following two important sections:

"Where a pensioner is the owner of an interest in a dwelling house in which he resides and the Commission accepts a transfer to it of such interest, the pension payable to the pensioner shall not be subject to any reduction in respect of the annual value of such interest, but the Commission shall, on the death of the pensioner or upon his ceasing to use such dwelling house as his place of residence, be entitled to sell the pensioner's interest therein and to retain out of the proceeds of such sale the amount of all payments made to the pensioner by way of pension in excess of the amount he would have received if such interest had not been transferred to the Commission, together with interest on the said payments at the rate of 5 per cent. per annum, compound annually.

"The Commission shall be entitled to recover out of the estate of any deceased pensioner, as a debt due by the pensioner to the Commission, the sum of the pension payments made to such pensioner from time to time, together with interest at the rate of 5 per cent. per annum compound annually, provided, however, no claim shall be made by the Commission for the recovery of such debt directly or indirectly out of any part of the pensioner's estate which passes by will or on an intestacy to any other pensioner or to any person who has, since the grant of such pension or for the last three years during which such pension has continued to be paid, regularly contributed to the support of the pensioner by the payment of money or otherwise to the extent which, having regard to the means of the person so having contributed, is considered by the Commission to be reasonable."

Payment of pensions to old people's homes, houses of refuge, and similar institutions, instead of to the pensioners residing therein—a feature of the Province's scheme that has been forecast repeatedly up to date—is authorized under the regulations that the Government may pass pursuant to the act.

## Now It's Fish Stories Over the Radio But They Will Be Well Vouched For

### Government Plans Educational Campaign on the Problem and Need of Conserving Game Denizens of Provincial Waters

That the Ontario Government is planning an educational campaign involving the use of radio, special lectures in various parts of the Province and a semi-monthly bulletin service to keep the people of the Province informed on the problem and the need of conserving the fish life in Provincial waters was intimated yesterday by Hon. Charles McCrea.

During the sitting of the Legislative Committee on Fish and Game yesterday, and the following an interesting address by H. H. MacKay, Government biologist, on various phases of fish conservation it was suggested that Mr. MacKay speak in various parts of the Province, and that that department issue a letter on the fish situation.

Mr. McCrea told the committee that the department had in view a dissemination of information on the subject which would include lectures by Mr. MacKay, and the publication of a general bulletin by the Fish Culture Branch.

William Newman (Liberal, North Victoria), suggested the use of radio, and Mr. McCrea deemed this a very good proposal.
