## \$3,735,753 IS SPENT ON NORTHERN ROADS IN LAST FISCAL YEAR

## Activities of Development Branch Outlined in Report

According to the annual report of the Department of Northern Development, which was tabled in the Legislature yesterday the Ontario Government spent \$3,735,753.32 during the last fiscal year on the maintenance and construction of roads in the northern section of the Province. Of this sum, \$359. 383.68 was devoted to colonization roads

Other activities of the department included the rendering of assistance to creameries being operated in the North. and the purchase of cattle and seed grain for settlers on a loan basis. For the financing of cattle purchases the department spent \$11,388.57, and for seed grain, \$12,341.10. Aid to creameries and grain elevators totalled \$2,175.

The net amount of loans issued was \$52,850. It is stated that there were 377 applications for loans received and 174 granted. The average loan over the several years in which the department has been in operation has been \$355.07, says the report. F. Dane, Settlers' Lean Commission-

er, stated that the settlers have met their principal and interest payments in a most gratifying manner. The pioneering spirit, he states, is still in the people of the North and they are looking forward with great expectations to the coming summer when they hope to be able to make up their loses of last year.

## STRICTLY ENFORCED Seizures Are Summarized in

Annual Report to Legislature Some idea of the very strict enforcement of the game laws of Ontario as practiced by the Game and Fisheries Department, Queen's Park, can be gain\_

ed from the annual report of that branch of the service which was tabled in the Ontario Legislature yesterday. "Enforcement was performed in a satisfactory manner by the field officers charged with the work," says the report, "and the service rendered by the District Wardens and the various overseers under their respective jurisdictions was capably augmented during the

hunting seasons by additional seasonal periods for the better protection of fish and game, and enforcement of the Act." In 916 cases in which parties were

spring and fall spawning and overseers appointed during charged with fish and game violations, convictions were secured. Fines and costs assessed in these cases amounted to \$18,933.35. In 893 of these cases seizures of goods and equipment were made.
