Extra space 15 cents per line first insertion.  
Each additional insertion 50 per cent. of above rates.

Application to surrender Letters Patent, or Resolution to wind up a Corporation, first insertion, not exceeding two-inch space . . . . . 4.00  
Extra space 15 cents per line first insertion.

Notice to Creditors, first insertion, not exceeding three-inch space . . . . . 6.00  
Extra space 15 cents per line first insertion.  
Each additional insertion 50 per cent. of above rates.

#### DISSOLUTION OF PARTNERSHIP:

Dissolution of Partnership, first insertion, not exceeding two-inch space . . . . . \$4.00  
Extra space 15 cents per line, first insertion.  
Each additional insertion 50 per cent. of above rates.

#### MISCELLANEOUS ADVERTISING:

Miscellaneous advertisements (not otherwise specified), first insertion not exceeding two-inch space . . . . . 4.00  
Extra space 15 cents per line.  
Each additional insertion 50 per cent. of above rates.

NOTE: Where rates are chargeable according to line measurement the basis is an agate line—14 lines to the inch.
