would have given COLLINGWOOD just about the right amount of time to have got up to the Port Arthur shipyard and to pay off there on Wednesday, December 12th after her crew laid her up.

Mr. Berry has searched the vessel passages and has been unable to find any activity of MARUBA after the 1923 season, and this certainly does not surprise us because of what we know about her Thompson ownership situation during this period.

And so, thanks to the help of our members, and particularly the assistance of John Tackaberry and Sterling Berry, we think we have taken the story of MARUBA as far as we can. Now, if only we could find a photo of her being rebuilt at Ashtabula or laid up at Cleveland before going to the landfill site that was to be the final resting place of her bones...!
