## Milton teen killed in street racing crash

A late-night street racing incident in Mississauga claimed the life of a young Milton woman Monday.

Peel Regional Police Service spokesperson Const. Iryna Yashnyk told the Milton Champion that the 19year-old passenger was pronounced dead at the scene of a crash into a pole near Mavis Road and Eglinton Avenue West at about 11

Yashnyk said it's believed the accident occurred during "street racing activity."

A 21-year-old woman was seriously injured in the crash and taken to a trauma centre, while the male driver was transported to a local hospital with non-lifethreatening injuries.

The two drivers - both

men, 20 and 22 years of age are in custody and face charges of criminal negligence causing death.

Further charges are pending, according to Yashnyk.

The name of the deceased woman has not yet been released.

Any witnessed to this incident are asked to contact Peel police.

## Man arrested after family disturbance

A Milton man faces charges in connection with a 'family dispute Sunday evening. At 7:25 p.m., police officers responded to an incident at a home on Messure Crescent, where it was discovered that a male adult had allegedly committed an assault on one of the residents and damaged proper-

ty in the house.

Police attempted to negotiate with the man, but he refused to co-operate.

Detectives and members of the tactical rescue unit joined uniform officers on the scene, a perimeter was established and judicial authorization to enter the home was obtained.

Six hours after the incident began and after a brief struggle with tactical officers, the suspect was arrested. No injuries were reported. A 29-year-old Milton man, whose name will not be released to protect the identity of the victim, is facing charges of assault and mischief/damage to property.
