out Friday, including the Lifetime Achievement accolade.

The Citizens of the Year honour went to Campbellville residents Liz and Peter Lambrick, who both moved to Canada from the United Kingdom, in 2000 and 1973, respectively.

Liz is past president of the Campbellville Community Association, a key organizer of the Santa Claus Parade and the committee that brought the RCMP Musical Ride to Campbellville last summer.

She also operates a Guelph Line roadside market, Busy Liz's Farm Shop.

Peter is a director with the Ontario Federation of Agriculture and member of the Halton Federation of Agriculture and the region's natural heritage advisory committee.

He said the "little bits" of work he does in the Milton and agricultural communities are "what we can do, and should do."

"It does not happen overnight. You have to be prepared to be persistent and keep moving the yardsticks ahead in small doses. It's the little bits that add up to the big win in the end," said Peter.

to be prepared and do the volunteering and be part of the community, before you can start objecting to how things have gone. You've got to be involved."

David Coulter garnered the Joyce Hagevik Volunteer of the Year Award for his involvement with the Milton haunted house, raising more than \$70,000 for the MDHF to purchase new medical equipment and facility improvements.

"The hospital makes its mission to get in and out as soon as possible. To have a new hospital for all the

new tools and doctors is an added bonus to "being a small community," said Coulter.

Each year, since 2012, he spent hundreds of hours creating, building and operating the haunted house with the assistance of high school students.

Coulter said he was shocked when he was told he was receiving the accolade, as it was "completely out of left field. It's truly an honour."

The Honorary Community Builders Award went to MDHF and its Our Home, Our Hospital Campaign team, which raised more than \$30 million to equip the hospital expansion.

Brian Penman, campaign co-chair and MDHF chair, noted the funds went toward erecting a new 330,000-square-foot building with 7,300 pieces of new, state-of-the-art equipment.

"Who would have ever thought that little old Milton could raise \$30 million? We did it, (though)," said Penman.

The MDHF chair gave kudos to the Milton chamber for recognizing a group that collected funds to help build a hospital.

"It's wonderful," said Penman. "This is a large group and we're being recognized. Couldn't ask for more."
