TAKE NOTICE THAT the Council of the Corporation of the Town of Milton passed By-law Number 064-2018 on the 23<sup>rd</sup> day of July 2018 under Section 34 of the *Planning Act*, R.S.O. 1990,c.P.13, as amended. This By-law amends the Town of Milton Zoning By-law No. 016-2014, as amended.

AND TAKE FURTHER NOTICE THAT the Corporation of the Town of Milton initiated this amendment and as per Section 34(18) of the *Planning Act*, R.S.O. 1990,c.P.13, as amended, notice shall be given to any prescribed person or public body who has the right to appeal this by-law. If you choose not to appeal this by-law, no further action is necessary.

### Purpose and Effect of Zoning By-law Amendment 064-2018:

The purpose of the zoning by-law amendment is to remove the existing site-specific Business Park (M1\*251) Zone and replace it with the Business Park (M1) Zone and repeal By-law No. 021-2018 on the subject lands.

There are no active applications under the Planning Act, pertaining to these lands. All public comments received, if any, were considered in the decision rendered on this file.

### Should You Wish To Appeal:


If you intend to appeal, a Notice of Appeal must be filed with the Town Clerk, Corporation of the Town of Milton, 150 Mary Street, Milton, ON, L9T 6Z5, no later than **20 days** from the date of this Notice and shall include:

- 1. The reasons for the appeal.
- 2. A completed A1 Appellant Form. This form is to be completed by the appellant for appeals relating to the official plan amendment and is available on the Environment and Land Tribunals Ontario website at www.elto.gov.on.ca/Tribunal/Ipat.
- 3. A fee in the amount of \$300.00, pursuant to the Local Planning Appeal Tribunal Act, 2017, S.O. 2017, c. 23, Sched. 1, payable by certified cheque or money order to the "Minister of Finance".

The last day for filing a Notice of Appeal is 4:30 p.m. on Wednesday, August 22, 2018.

### Who Can File an Appeal:

Only individuals, corporations and public bodies may appeal a by-law to Local Planning Appeal Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.



No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the Council or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

# HANDGUNS USED IN CAMPBELLVILLE BANK ROBBERY, TWO SUSPECTS BEING HUNTED

Halton police are searching for two suspects following an armed robbery at the Campbell-ville Scotiabank Monday.

Officers and the K9 unit were called to the Main Street branch shortly before 12:30 p.m., after two men with handguns fled in a black hatchback (no licence plate plate available) after grabbing an undisclosed amount of cash.

There were no injuries during the altercation.

The two suspects are described as black males between 20 and 25 years of age.

One is described as 5-foot-10 with a thin build, wearing a dark hoodie, dark pants and sunglasses.

The other is described as 5foot-8 with a thin build and short black hear, wearing a button-up shirt with long sleeves, dark pants, a baseball cap and sunglasses.

They were still at large at press time.
