





## REMEMBRANCE DAY MILTON: JIME TO HONOUR OUR VETERANS

### TOWN'S BELLS WILL RING TO MARK 100TH ANNIVERSARY OF **END OF FIRST** WORLD WAR

Miltonians can expect a little added recognition of Remembrance Day this coming weekend.

At sunset Sunday, Nov. 11, the bells of Milton — including the one at the town hall and at local churches and schools - will ring out 100 times to mark the 100th anniversary of the end of the First World War.

During the '100 Bells of Peace', area residents are asked to take a moment to reflect on the sacrifice made by veterans during all wars and conflicts throughout history.

Saturday afternoon will see veterans and dignitaries march from the Royal Canadian Legion (Branch No. 136, 21 Charles St.) to the town hall's Victoria Park cenotaph, where a 2 p.m. Remembrance Day service will be held.

A reception at the Legion will follow.

A traditional Nov. 11 service will be held from 10:30 to 11:30 a.m. at Evergreen Cemetery on Ontario Street.

Poppies will be sold throughout town until Sunday, giving Miltonians an opportunity to show their support for our veterans.
