

NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND.

IN THE MATTER OF the proposed expropriation of land by The Regional Municipality of Halton being All Right, Title and Interest (Fee Simple) and a 2-year Temporary Limited Interest (temporary easement) in the lands described in Schedule A set out herein, registered in the Land Registry Office for the Land Titles Division of Halton No. (20), for the municipal purpose of facilitating the widening and reconstruction of Britannia Road (Regional Road No. 6) from James Snow Parkway (Regional Road No. 4) to Highway 407 ETR in the Town of Milton, (the "Britannia Road Reconstruction").

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate All Right, Title and Interest (Fee Simple) and a 2-year Temporary Limited Interest (temporary easement) in the lands described in Schedule A set out herein, registered in the Land Registry Office for the Land Titles Division of Halton No. (20), for the municipal purpose of facilitating the widening and reconstruction of Britannia Road (Regional Road No. 6) from James Snow Parkway (Regional Road No. 4) to Highway 407 ETR in the Town of Milton, (the "Britannia Road Reconstruction").

Any owner of lands in respect of which notice is given who desires a hearing into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing

- in the case of a registered owner, served personally or by registered mail within thirty (30) days after the registered owner is served with the notice, or, when the registered owner is served by publication, within thirty (30) days after the first publication of the notice;
- b) in the case of an owner who is not a registered owner, within thirty (30) days after the first publication of the notice.
