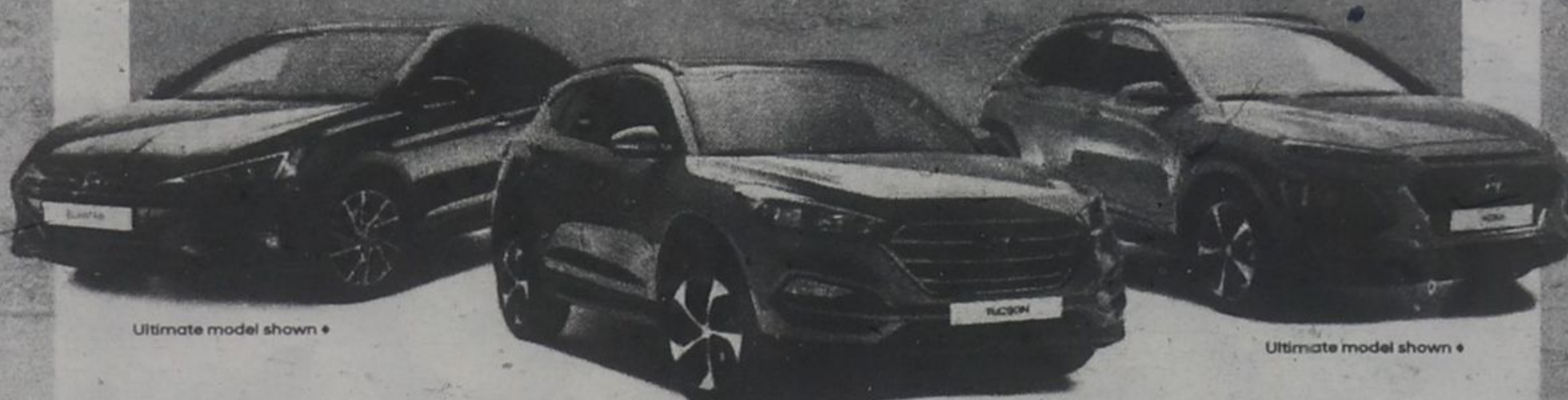

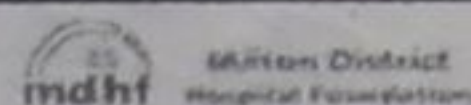

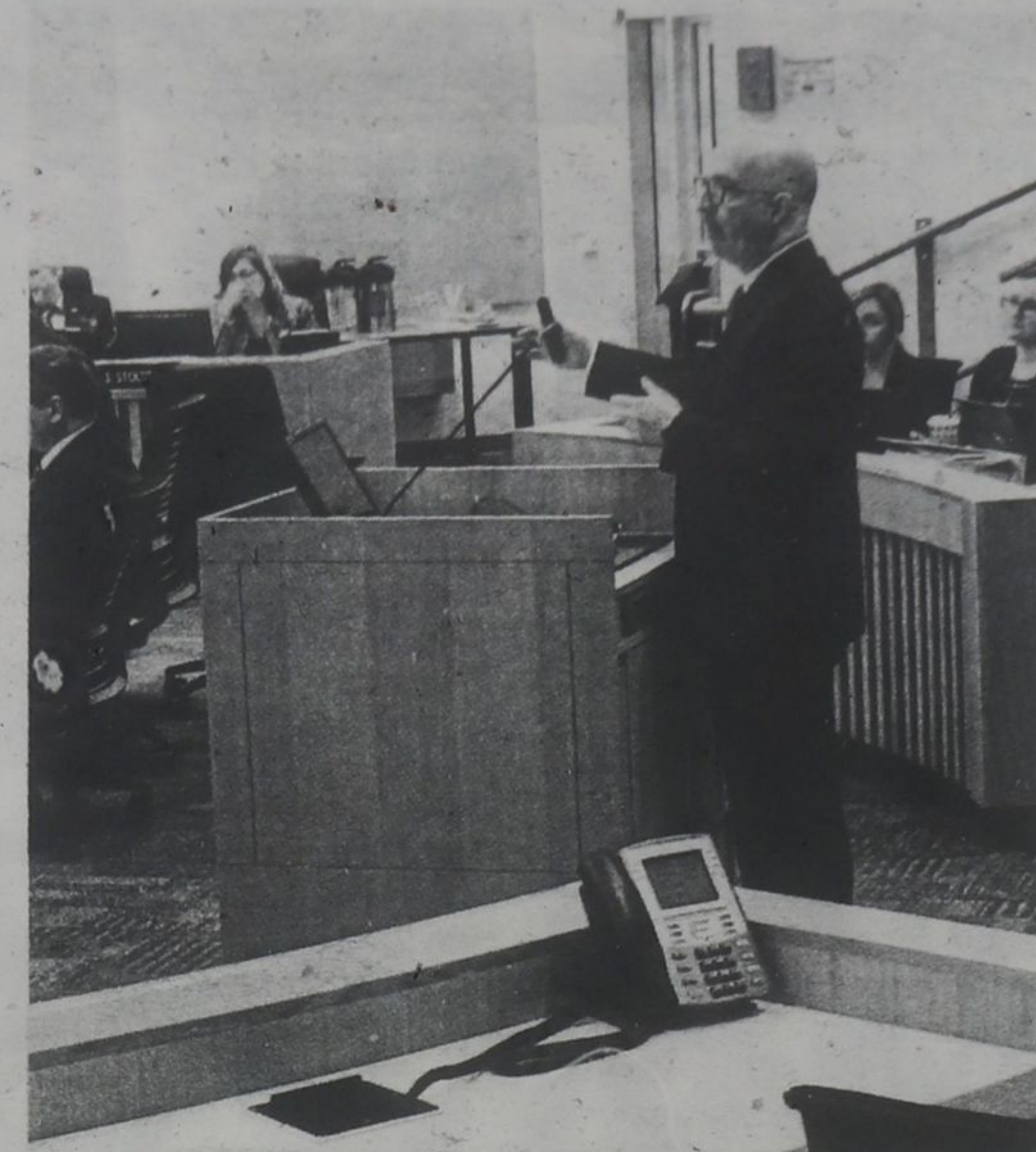

program and other revenue (seven per cent); federal subsidies (one per cent) and supplementary taxes (one per cent).

Some of the tax budget highlights include the following budget increases from the 2018 budget to the 2019 requested budget: \$2 million in roads operations going toward addressing rising State-of-Good-Repair needs, road maintenance and three new red light cameras; \$900,000 in paramedic services to address call volumes; \$900,000 in waste management to address inflation and tonnage growth, as well as organics market pressure; \$700,000 in planning services to support growth; \$400,000 in quality and service integration, primarily to fund the Halton Region Community Investment Fund; \$1.6 million for boards and agencies; and \$2.7 million for non-program services.

Regarding the rate-supported budget, residents can expect a change of 3.7 per cent in water and wastewater rates for 2019 (an increase to \$999 from \$964 for a typical household).

This figure is based on zero per cent consumption growth and 1.5 per cent customer growth, Scinocca said, adding that with water conservation efforts

and better systems, the overall consumption rate is not growing, however, the customer base is on the rise.

The region's net expenditures for the rate-supported budget are projected to be \$205.6 million.

Halton Region will be holding a budget council meeting on Jan. 9 at 9:30 a.m. The budget will subsequently go to council for approval on Jan. 16. Both

meetings will take place in Council Chambers at Halton Regional Centre (1151 Bronte Road, Oakville).
