QUESTIONS BOARD SALE OF SCHOOL PLAY AREA

Dear Mr. Dills:

It is hoped you will find the attached letter of sufficient public interest to publish because it involves the sale of school property heretofore considered too valuable to lose; transfer of ownership without due consideration to the future and what it will mean to the J.M. Denyes school area in particular and to the whole Town of Milton.

Dear Mr. Noble:

You have been approached before by the undersigned, on behalf of the Home and School Association, J. M. Denyes School, regarding the Halton County School Board's decision to sell to Focus Development Ltd., part of the southerly boundary of the school property. Not as an official spokesman, but nevertheless voicing the collective thoughts of many of the people in that school area and of the Town of Milton, I am now writing to ask you and the School Board some questions for which we would like the answers.

After attending last night's Committee of Adjustment meeting regarding this proposed sale, along with about 20 other perturbed citizens of the school area (only a few of whom are actual neighbors to the school) I am abundantly aware we ought first to have more forcefully approached the School Board with our objections. I might say we overwhelmed the representative for Focus Development by the number of very strong objections we hold to the sale.

It appears that originally the representative for Focus Development Ltd., made two offers to the School Board, either to sell to the Board, "Block B" as it is known or buy from the Board, a piece of school property to increase the depth of said piece of Heslop Rd. frontage. These are valid ways to make usable a formerly narrow strip of land.

However, we have many reasons for asking that reconsideration be given to the proposal to sell and we ask you:

. Why, even though you told me the school grounds presently exceed the minimum required area, do you plan to deprive pupils of a safe play area during school hours, evenings, weekends and all summer long?

2. In view of the addition to the school, proposed for this year (a fact professed not to be known by some of the Planning Board, or the representative for Focus Development) are the pupils not immediately faced with a reduced play area which on fine days, allows the whole school ample room for healthy exercise?

3. Is there not far more possibility of the school population increasing in the very near future, than ever decreasing, especially if houses are built thereon, and on properties already slated for development such as that on Bronte St.,

(also in our school area)? 4. Will this sale benefit the School Board financially, enough to make fit for use the reduced playground area, part of which is now too wet to be used for most of the year? And in future will we, the taxpayers, not pay far, far more to replace or establish a green belt or a recreational area where it is already so greatly needed?

Why, when Milton School Board refused for years to lose this potential open area, has the Halton County Board so willingly offered to let it be sold?

6. Most important perhaps, why was this apparently surplus land not made available first to the Town of Milton, publicly advertised, or allowed the opportunity of becoming beneficial to the whole community?

As our school trustee and representative Some examples: A higher smoke stack to the Halton County School Board, I feel we can expect to have this matter immediately given the attention it deserves and I propose to send a copy of this letter to the Chairman of your Board. If possible, when this is placed on your agenda, perhaps we could be notified so that personal representation might be made, or we would welcome a public meeting called in Milton to further discuss this matter. Had the School Board been represented at the meeting last night, you would be well aware, I am sure, that I am but one of many more concerned citizens.

PRESSING FOR CHANGES BEFORE WHITE PAPER PASSES

(Editor's Note - Recently Champion editor Roy Downs wrote Halton MP Rud Whiting a letter, expressing his personal concern over some of the proposed tax policies in Federal Minister of Finance Edgar Benson's White Paper on Taxation. With the permission of Mr. Whiting, his reply is reprinted below:

Dear Roy:

Thank you for your letter expressing your views on the White Paper on Tax Reform.

I have received literally hundreds of letters from constituents on this subject. Unfortunately, it has become impossible for me to write an individual reply to each one. I would, however, like to assure you that I have read your letter very carefully and noted its contents.

The White Paper contains proposals as to how tax reform might be brought about. The Hon. Mr. Benson has stated on numerous occasions that the Government is open to suggestions with respect to making changes in the White Paper and indeed some have already been made

The great majority of my letters are primarily concerned with the deemed realization of capital gains every five years on equity ownership of widely held corporations and elimination of the preferred tax rate on the first \$35,000. of corporate earnings. These were two areas which caused me much concern. I was, therefore, very pleased when the Minister of Finance, Mr. Benson, recently announced that the proposal dealing with deemed realization had already revealed some administrative problems, and would have to be re-examined. In addition he indicated concern for the small corporation and asked the Parliamentary Committee currently studying the White Paper for their comments and suggestions on this matter.

Some of the letters also indicated concern about the proposed capital gains tax on the appreciation in the value of homes which exceeds the sum of \$1000. per year of occupancy plus costs of repairs. Mr. Benson has stated that this proposal will not produce a large revenue. I believe a total exemption from capital gains tax should be recommended as long as the owner has held it for a specified length of time - say a year or two. For the other personal possessions, the exemption could be raised from the proposed \$500 to several thousand dollars with no serious loss to the Treasury.

Another area of the White paper proposals is the personal taxation of those earning from \$10,000. to \$20,000. per year. These Canadians already are taxed very heavily by all levels of government and the proposed added tax could have an adverse effect on their incentives and their desire to remain in Canada.

At this point I would like to state that I feel the White Paper is a worthwhile document and while there are certainly some provisions which should be carefully examined, and in my opinion changed, the overall proposal is a worthwhile one. However, may I emphasize that without substantial changes (which I feel will be made) I could not support the White Paper in its present form.

I wish to assure you that my interests are those of my constituents and I will work to help bring in legislation on taxation which is equitable and in the best interests of the Canadian people.

In closing my I again thank you for writing me on this subject. I am taking the liberty of forwarding a copy of your letter to Mr. Gaston Clermont, M.P., Chairman of the Standing Committee of the House of Commons on Finance, Trade and Economic Affairs, so that he, and the members of this Committee, may be made aware of your constructive comments on the White Paper.


