Condominium project explained to council

"Milton Mews", a 117-unit condominium project on Ontario St. N. proposed by Toretta Corporation Ltd., was explained in detail to members of Milton Council at their meeting Monday by Victor Hinde, representing the developers.

Although councillors looked with favor on most of the details of the project—the town's first condominium-concern was expressed about a creek that flows through the property. And Councillor Colin Smillie says he doesn't like the name of the project, either.

The Mews would contain 117 three-storey condomium homes, arranged in several separate blocks of buildings, and would be located on the east side of Ontario St. just north of the Mayfair Apartments. Each unit would be purchased by the occupant and controlled by a corporation

Planning has recommended seven conditions the firm must meet before approval will be granted, and Mr. Hinde assured council his firm project to the Torprop subdivision to be built to the east, to allow the condominium tenants


