A sporting chance

To the Editor:

This weekend I had the pleasure of being the meet director at an Ontario Gymnastics Federation competition. My work was made light by the enjoyment in watching and appreciating the skills and artistry of some 80 young ladies. It also filled me with pride to see two gymnasts from Milton almost walk away with top honors. Paula Geniole took the all round silver medal, whilst Tammy French won the bronze medal in the Argo "B" competition. Each girl experienced a momentary lack of judgement and attention in a different single event. But for those individual lapses, either Paula or Tammy may well have achieved the top honor and brought home to Milton a gold medal. As it is, both girls will, on May 12th, compete in the Ontario Provincial Championships.

Three weeks ago my daughter Suzanne Wood also qualified for the provincial championships as a Tyro B gymnast. However, both Tammy and Suzanne who were stalwarts of the Milton Springers club, now compete for Oakville Antoinettes. Why the switch in alleigance? Simply, to take advantage of, better, facilities, better equipment and more hours in the gym. The driving motivation vs. competitive ambition we, parents are only to willing to sacrifice our own leisure time to drive the kids to and from Oakville three to five times a week.

Tammy French is considered to have the potential to reach the level of national competition. If she has it, the excellent gym facilities and coaching in Oakville will endeavor to see that she reaches her potential. With the Milton Springers, Paula Geniole works under the excellent guidance of Head Coach Janet Campbell. Paula also is beginning to show that she has the basic talent and inner drive to become a top cc Mayor Don Gordon. flight gymnast. But despite first class coaching, will she be able to reach her potential without the availability of adequate hym time. At the moment the Springers are able to use their own equipment in the excellent E. C. Drury gymnasium but are squeezed tightly for time and, therefore, revenue-earning ability. A gymnast, just like an ice skater must work long and constant hours in the gym to perfect her technics. Three hours, three times a week sharing apparatus and facilities with 30 other hopefuls is inadequate. Will Paula therefore, be denied her potential in Milton?

Before Paula there was Nancie McWhirter who left Milton to become a national competitor. Sara Aggis joined Cambridge and now competes as a National level 1. Working in the gym along with Paula are younger carbon copies, to commence on a national training program which demands a dedication of regular gym time.

What is to be done for these athletes and those that could follow over the next few years if the Milton Springers program continues to develop?

Towards the end of last year the club executive had sufficient forsight to bring before the Town Council a request for a suitable facility. The club's request was simply for space, its members being prepared to convert and decorate at its own expense. The most likely space available was considered the Old Fire Hall on Main Street. The Fire Hall as a potential gym is by no means ideal, but with some hard work, a good deal of inspiration and its availability seven days a week, the modified facility would suffice as an interim period of say three years. With a facility available to the club on a full time basis, the current recreation program, which is the basis for the competitive team, would be considerably enhanced. The recreation program is directed by Head Coach Janet Campbell, is the basis from which the club draws its future competitive members. Without the availability of a more permanent gym, the recreation program boasting 540 registrations annually, now with a waiting list, will be considerably curtailed as Board of Education facilities become less available and at a threatened premium cost. on behalf of the town parks and recreation department and has grown threefold since the Springers professional coaching involvement.

Unfortunately, although the Town Council listened with a sympathetic ear to the plea of its young gymnasts and promised to study their needs, the study has produced no progressive results to date. Time of course, does not stand still for the athlete. But it seems the only available municipal building in town that could house a gym is also of interest for the summer flea market, additional town hall offices, and maybe even our senior citizens. Surely with a glut of office space that we have in town, on and around Main Street, it cannot be necessary to convert the Fire Hall for administrative purposes. Milton isn't too big and any of its town departments could be conveniently located within walking distance of downtown. And surely council will not seriously consider a suggested expenditure out of taxes of \$150,000 to convert the upper level of the Fire Hall to offices. If this kind of money is available why not put it into some of the vacant commercial properties around town and relieve the property taxes.

But in the meantime, what about Paula Geniole and her eager young colleagues. Are they going to be given a sporting chance here in Milton. Must they also look elsewhere or merely lower their sights to more modest ambitions. I hope not! For them, a good gymnasium, not half a facility, is now essential! Although mine is an independent opinion, I am of course, a biased parent, but at some competitive meet in the near future, how I would like to see a Milton gymnast mount that winners

A garbage solution

Today we hear much about P.C.B.'s and other hazardous liquid wastes and the problem of transporting such wastes for safe disposal. The public is reluctant to accept present methods of incineration of hazardous wastes, including P.C.B.'s. Their concern is justified because of the high temperatures that have to be sustained to effectively dispose of toxic substances.

The fact is, liquid wastes, including oil containing P.C.B.'s can be safely disposed in a mobile unit, thus eliminating the necessity and risk of transporting hazardous liquid wastes to a disposal centre. The method is the Plasma Arc Gun, a technique that has been proven in six years of operation at a plant in North Carolina. Its Canadian subsidary is in Mount Royal, Quebec. The Plasma Arc Gun is similar to an arc welder. An arc is formed, approximately one metre long, this arc is contained within a vortex of helium, argon and oxygen, giving it a swirling or corkscrew motion. The temperature sustained, 100,000 F. is the hottest known to man.

Stationary plants can dispose of municipal and residential refuse, sewage sludge, auto tires, all types of wood waste, plastics, waste oils, lubricants, odorous gases, and organic wastes. A portable unit can be adapted to a tractor-trailer and driven to sites or plants to dispose of hazardous wastes. There is a by-product of Methane, and an inert granular material which can be used for road building or as a building material.

Such units are energy intensive, but isn't Ontario Hydro telling us we have too much hydro on tap? Shouldn't we weigh the pros and cons? Effective safe disposal of wastes, including hazardous materials, against the environmental hazards of landfilling, disposal sites, transportation of hazardous wastes, spillage of liquid waste. The costs are not exorbitant, about \$850,000 for a mobile liquid waste unit, and about three and a half million dollars for a 100-ton-per-day garbage, energyproducing unit
