Closed door school board and chamber

When Halton Board of Education trustees meet behind closed doors next week to explain their budgeting problems to municipal councillors, they will not have an official Milton representative.

Milton councillors decided Monday not to send one of their members to the session planned by the Board of Educaton to quell rising criticism over the \$131 million budget trustees approved for 1982.

In their criticisms of the plan, councillors were divided over whether they disliked the idea or it

"I think the message is being missed here," commented Coun. Rick Day. "I understand the problems they are having. We don't have to go there to be told why their energy costs have gone up, or about their problems with the teachers federa-

"The whole problem is that the thing has become too big and unwieldy for local government," he said. "We're not complaining that they didn't try, it's just the whole thing about Regional education that has us upset."

The Board of Education plans a special information night May 25 to tell local councillors and members of the Chamber of Commerce about the factors that forced trustees to approve such a large budget hike.

The portion of the Board's budget to be paid by Milton has increased by 22 per cent and that has caused some anger among councillors and citizens. "This system has just become too big, too expen-

sive, too unweidly and too uniform," he said. "These decisions go higher than those part-time people down there," he added.

Coun. Don Knight added that Chamber of Commerce members would be meeting later this week to discuss the invitation they received to the same session "and the feeling is that they will not be attending either".

"The regional board of education is never going to be able to handle this problem because it is the problem," commented Coun. Day. "Our debate has to be with the provincial government that constituted Regional government in the first place."

Mayor Gord Krantz said it was the fact that the session was to be secret that made him reluctant to


