## Near drowning at Kelso

A 27-year-old Toronto man is fighting for his life following a swimming accident at Kelso Lake Monday afternoon.

At press time, Farhad Bana of 280 Wellsley St. E., Toronto was listed as unconscious and in critical condition at Hamilton General Hospital.

The incident occurred at approximately 3 p.m. when Mr. Bana, accompanied by his girlfriend Leeta Nerine 20, of Thornhill and Michael Sguambelluri of Toronto were returning from a canoe ride on the lake.

Mr. Bana decided he was going to swim back to shore, approximately 40 feet away and jumped from the canoe.

His two friends made their way back to the canoe rental station, while Mr. Bana swam south to the Kelso beach area.

Halton Regional Police said the first persons to notice something amiss were Peter and Eileen Atkinson of 830 Coulson Ave., Milton, who were standing on the shore of the lake.

They told police Mr. Bana suddenly put his hand up in the air and disappeared. He was about 20 feet from shore.

Mr. Atkinson shouted for help and no less than 15 people including several life guards began an immediate search of the area.

Seven dives were made in a north-south direction, but divers were unable to locate the man and switched their search to an east-west area.

On the second dive, lifeguard David Dakers of Oakville found Mr. Bana lying facedown on the bottom of the lake in about 20 feet of water.

Assisted by Scott Weston, an instructor guard at Kelso, Mr. Dakers brought Mr. Bana to shore.

Artificial respiration and cardio pulmonary resuscitation were immediately administered and Mr. Bana was rushed to Milton District Hospital.

According to police, at that time no pulse nor heart beat could be detected, but Mr. Bana began breathing a short time later.

He was later transferred to Hamilton General Hospital.

ocurred in an unsupervised area of the lake. Visibility in the water was between 12 and 18 inches and there were considerable weeds in that area.

Three life jackets were in the canoe, but Mr. Bana was not wearing one when the accident occurred, said police.

Investigating officer Constable Rod Gilbert commended Kelso Lake staff for "the professional manner in which they reacted to the situation."

Mr. Bana, who lives alone, is employed as a waiter at Toronto's CN Tower. His parents live in Pakistan and he has one uncle living in Canada.

# Annual police report favorable

Halton police commissioners seized the opportunity Thursday to bathe in the afterglow of a favorable provincial inspection report singing the praises of the local force.

Commission chairman Judge Joseph Scime said Halton police force was "second to none in the province of Ontario."

Commissioner Ric Morrow lauded the department "as a citizen and recent member of the board". He likened the report to a child coming home from school with an excellent report card.

Commissioner James Grive, of Burlington, said, "indeed, this is an exciting time to be part of this organization."

The benevolent outpouring stemmed from an Ontario Police Commission report conducted earlier this year by K.W. Schultz, a services officer of the OPC inspectorate branch. The report is a 13-page document, plus two additional pages of recommendations.

The mostly favorable comments contained in

the 1982 report are in stark contrast to a report completed three years ago which was highly critical of the Halton force.

The most recent report addresses 37 issues, commenting briefly on each. Included in the list are remarks on accounting, discipline, internal affairs, preventive policing, training and morale.

Under accounting, the report states: "The budget preparation and total accounting system for the Halton Regional Police Force is in good order. Other municipal police forces should be encouraged to emulate the preparation of their 1982 program budget."

The report, addressing the force's discipline, noted members appear "motivated and proud of their organization." The Halton force has a discipline system engulfing at levels for the curing of minor disciplinary problems.

Proper procedure is being used in the handling of citizen complaints, according to the report. "All reports are properly investigated and documented," said the OPC evaluation.

Halton currently has an 18-member crime prevention team. This team is listed as "adequate" in the report. The same rating is given the training programs of the officers giving rise to "significant changes in the morale, loyalty and esprit de corps."

One of the few notes of discord in the report comes in the training evaluation. It says civilian members of the force feel overlooked and are not obtaining the additional training.

Among the sections of the report most favorable to the force is the evaluation of morale. States the report: "Members no longer think of themselves as still being part of the smaller municipalities and now consider themselves as totally immersed in their loyalties and dedication to the Halton Regional Police Force."

Police Chief James Harding appeared pleased by the report and told the local commission his force was "progressive and professional". Chief Harding noted as well that the department is more efficient than three years ago.

Reports into the 127 police departments in the province will now be an annual undertaking of the OPC, according to Gordon Hampson, OPC policy development officer. Previously investigative reports were done every few years, or when requested by officials of the force or government. There remains provision for the specially requested investigations, however.

"We don't run the Halton police force," said Mr. Hampson. "That is the responsibility of the local police commission."

The scolding 1979 report came as a result of a request from the Regional government.

The 1982 Halton inspection report was voted by the local commission to be made public. This was not an obligation of the Halton commission, said Hampson. He noted that the report became the property of the Halton commission.

## Main St. firms broken into

Halton Regional Police are investigating a series of break and enters of Main St. business premises that occurred over the holiday weekend.

An estimated \$70 cash was stolen from the float till at Borland's Photo Centre at 207 Main St. E. Thieves pried open a rear window. The theft occurred sometime between Monday and Tuesday morning.

Using a similar method of entry, persons made their way into The Tackle Shoppe at 219 Main St. E. It is unknown at this time if anything was removed.

Approximately \$115 cash was removed from the offices of The Canadian Champion at 191 Main St. Thieves smashed a rear window to get into the building.

A rear window was pried open at The Youth Centre at 181 Main St., but nothing was taken.

A cash drawer was also stolen from The Acorn Restaurant at 8 Martin St. Sunday evening, but the drawer contained no money, said police.

Police believe the above entries were likely done by the same person or persons.

Police are also investigating another weekend break-in at the offices of The Milton Tribune at 181 Main St. E.

Eleven-year-old David McGuigan of Court St. Milton reported to police finding a cash tray and pay envelopes Monday evening belonging to the Tribune. The items were found near railway tracks on Court St.

Tribune employees contacted by police were unaware of the theft, but further investigation revealed \$25 had been taken from a front office desk, \$168.10 from a pay envelope and an additional \$40 stolen from a second office desk.

## Trap club

"The main problem is the noise," Mr. Osso said after a recent council meeting.

A copy of the By-law is furnished herewith. A note giving an explanation of the purposes and effect of the By-law and stating the lands affected thereby is also furnished herewith.

**ANY PERSON INTERESTED MAY**, within twenty-one (21) days after the date of this notice, send by registered mail or deliver to the Clerk of the Town of Halton Hills notice of objection to approval of the said By-law or any part thereof and SHALL INDICATE THAT IF A HEARING IS HELD THE OBJECTOR OR AN AGENT WILL ATTEND AT THE HEARING TO STATE THE OBJECTION.

**ANY PERSON WISHING TO SUPPORT** the application for approval of the By-law may within twenty-one (21) days after the date of this notice, send by registered mail or deliver to the Clerk of the Town of Halton Hills, notice of his support of approval of the said By-law together with a request for notice of any hearing that may be held giving also the name and address to which such notice should be given.

**THE ONTARIO MUNICIPAL BOARD** may approve of the said By-law but before doing so it may appoint a time and place when any objection to the By-law will be considered. Notice of any hearing that may be held will be given only to persons who have filed an objection or notice of support, and who have left with or delivered to the Clerk, undersigned, the address to which notice of hearing is to be sent.

**THE CORPORATION OF THE TOWN OF HALTON HILLS**  
**BY-LAW NO. 82-61**

Being a By-law to amend Restricted Area (Zoning) By-law No. 57-91, as amended, of the former Town of Georgetown, now part of the Corporation of the Town of Halton Hills.

**WHEREAS** it is desired to clarify the requirement that no person shall erect any building or structure in any zone unless upon a lot which fronts on an improved public street;

**NOW, THEREFORE, COUNCIL FOR THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:**

1. A new section 4.11 shall be added to By-law No. 57-91 under the title, "Frontage on a Public Street", which shall read as follows:

"4.11. Frontage on a Public Street:

(a) No person shall erect any building or structure in any zone unless the lot upon which such building or structure is to be erected fronts on an improved public street.

(b) "Public Street" shall not include a lane or right-of-way.

(c) An "improved public street" means a street which has been constructed in such a manner so as to permit its use by normal vehicular traffic.

(d) Nothing in this section shall be interpreted to require frontage on an improved public street for condominium "units" as such word is defined in The Condominium Act, R.S.O. 1980 (the "Act") provided that the condominium "property", as such word is defined in the Act, has frontage on an improved public street.

**BY-LAW** read a first, second and third time and finally passed and enacted this 17th day of May, 1982.

**THE CORPORATION OF THE TOWN OF HALTON HILLS**  
**BY-LAW NO. 82-61**

**PURPOSE OF THE BY-LAW:**  
The Purpose of the By-law 82-61 is to amend Restricted Area (Zoning) By-law 57-91, as amended, to provide for a frontage requirement on a Public Street for any building or structure in any zone.

**EFFECT OF THE BY-LAW:**  
The effect of the By-law is to provide that, upon approval of the Ontario Municipal Board of By-law 82-61, no person(s) shall erect any building or structure in any zone unless the lot upon which such building or structure is to be erected fronts on an improved public street.

**LOCATION OF LANDS AFFECTED:**  
The lands affected by By-law 82-61 are those lands contained within the former Corporation of the Town of Georgetown, now part of The Corporation of the Town of Halton Hills.
