weekend the team travels to the big city of Toronto to compete in the TSSAA meet.

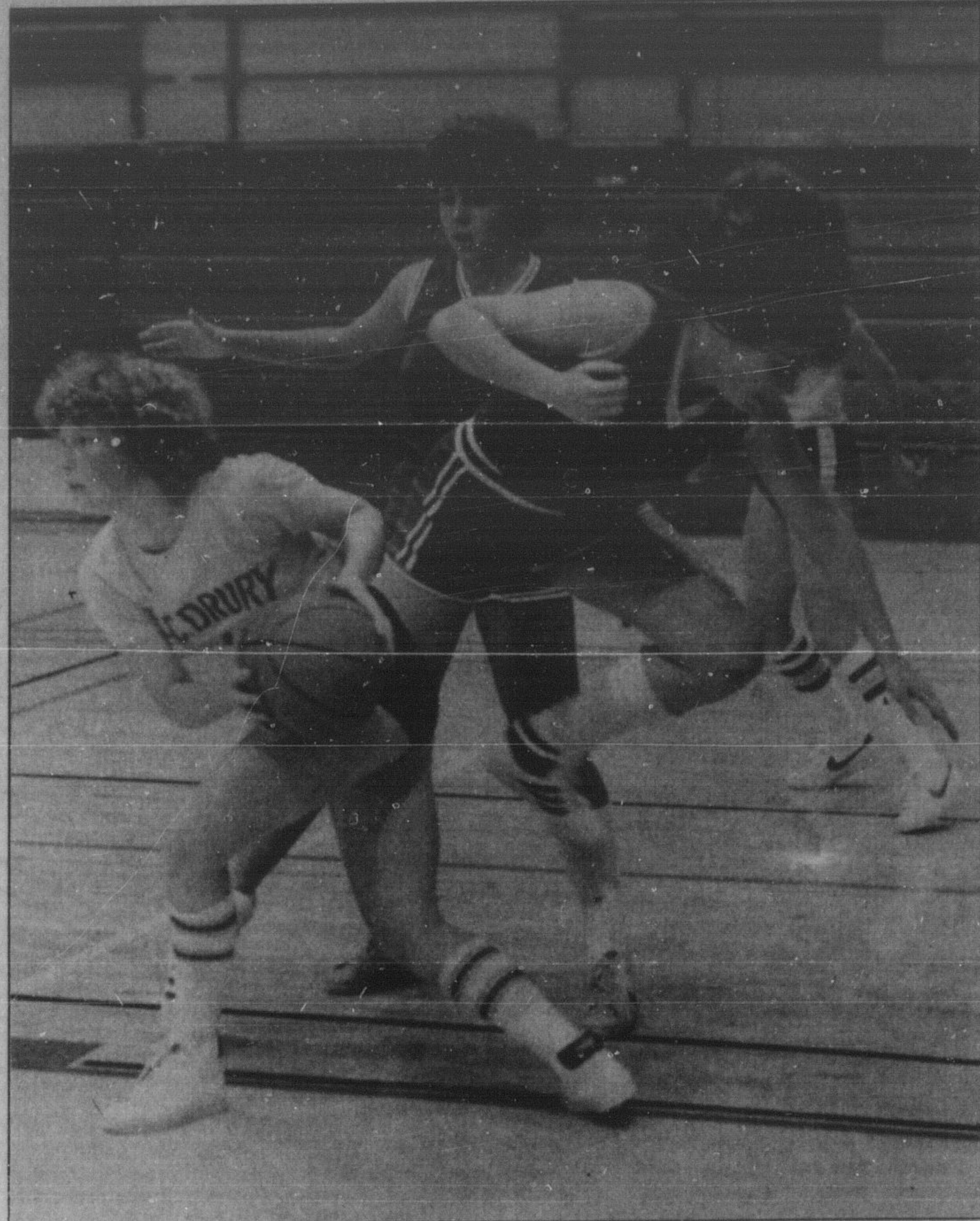
The boy's volleyball teams were both victorious against White Oaks. The juniors swept up three games straight 15-7, 15-8, 15-3.

Blades gain split in season openers

Milton Banvil Blades minor bantams split openers over the weekend.

The club dropped a 7-0 decision Saturday in Oakville, edged archival Georgetown 3-2 Sunday at Memorial Arena and had rallied for a 4-4 tie with Burlington Monday also at the Thompson Road arena.

Although Blades had a good number of exhibition games to get accustomed to the body-checking style of hockey, they completely forgot how it can be effective as Oakville skated through, around and by the Milton players to go ahead 1-0 after one period.

Oakville subsequently added three goals in each of the second and third periods past the goalkeeping duo of Don Durand and Alex Gianuzzi.

Sunday, Georgetown jumped in front 1-0 after one period before Robbie Wilson scored the equalizer for Milton with just 61 seconds left in the second period. Scott Ellwood assisted.

Three minutes into the third period, Georgetown again pulled ahead before Pat Butler knotted the score with Travis Cole picking up an assist at the 3:30 mark.

Wilson notched his second of the night for the winning goal with just over two minutes remaining in the game. Gianuzzi barred the door for the balance of the game against a strong attempt to preserve the club's first league win.

Against Burlington, Blades began with a similar type game they played against Oakville and forgot to take the man out of the play. Burlington capitalized to score four consecutive unanswered

goals for a 4-0 lead after after two periods.

Durand replaced Gianuzzi between the pipes and stymied the Burlington shooters long enough to allow Wilson to score three goals on one shift (in a 57-second span) to tie the score.

Geoff Pollen started the Blades on the comeback with the Club's first goal three minutes into the final frame. Cole and Doug Drennan earned assists.

Wilson went to work in fine fashion with Grant Thomson, Ellwood and Pollen earning assists.
