

# In the schools

## E. W. Foster

Construction on our new building continues to make considerable progress. Although the roof has not been started, the concrete floor slabs are poured and the walls are now ready for the installation of steel roofing joists. The contractor is proceeding to prepare for the installation of asphalt paving. Sodding and some paving have started and should be complete in mid-November. If all goes well, we should be able to enter our new home in February.

Meanwhile, students in grades 1 to 4 are temporarily located at Sam Sherratt Public School (Grades 1 and 4) or at the Ernest C. Drury School for the Hearing Impaired (Grades 2 and 3). Grades 5 and Kindergarten will be added in September 1983. Both staff and students at both locations are working hard to provide a feeling of "belonging" and an identity to the new E. W. Foster Public School, with visits to the job site, and related classroom activities which help to build our enthusiasm for the time we will all be together. The staff in both locations meet regularly in order to plan together and prepare for our move. E. W. Foster is fortunate to have a parent volunteer program actively in place, as well as student volunteers from the E.C. Drury High School, and the Trillium School.

Mr. Foster has had the opportunity to visit some of our students, and is also helping us in the development of a school logo. Students are now looking forward to return visits and an opportunity to have "our" Mr. Foster read a story to them.

The E. W. Foster students at Sherratt participated in their recent open house at Sherratt while students at the E.C. Drury location invited E. W. Foster parents and students from both locations, to attend an Open House on Oct. 6. We were extremely pleased with the attendance and the many kind words from parents. While at the E.C. Drury location, parents had an opportunity to visit the library and gyms shared with students from the Hearing Impaired School. This was a most successful evening, with approximately 90 per cent of the families in attendance.

The students at the Ernest C. Drury location have a unique opportunity to share facilities with the Hearing Impaired students. We share recesses and outdoor equipment as well as library and gyms. Plans are under way to "twin" classes and to provide further opportunities for the students to meet each other. We have had many, many, positive experiences to the benefit of both hearing and hearing impaired students, thanks to the kind hospitality of the staff and students here at Drury. We are certain that all students will remember their experiences here long after we move to our new location.

Over the past few months, in addition to preparing for our students for September, we continue to plan for our move. Some furniture for our new school is in use at Ernest C. Drury, and the balance has been ordered. Some of it is in storage and some will be delivered before Christmas. Many of the finishing details (e.g. colour, rugs) have also been decided.

We were extremely pleased recently to receive confirmation from the president of the Upper Burlington Optimist Club, Dave Downard, that E. W. Foster will receive funding for the purchase of a computer for our school. All staff and students are extremely pleased with their very kind and generous donation, and we look forward to receiving the computer early in the new year. Mrs. Rosemary Simpson, our librarian, will officially begin her duties at that time, and has already made plans to implement a computer program for the students. Many thanks again, to the Upper Burlington Optimist Club.

When we met with parents in June, Mr. Wiens, principal of E. W. Foster School, asked them for their support in helping us become part of the community. With a great deal of pride, we are pleased to report that we have received their support many times over and we look forward to many years of continued co-operation.

## 'Reflections Of His Love' film

Reflections Of His Love, a new film highlighting the life and ministry of Joni Eareckson, will be shown on Sunday, Oct. 24 at 6.30 p.m. at the Milton Alliance Church at Sam Sherratt Public School on Laurier Ave. The color feature is produced by World Wide Pictures, the film ministry of the Billy Graham Association.

Miss Eareckson is the star of a recent theatrical motion picture, Joni, which relates the story of her driving accident, as a young girl, which left her paralyzed from the neck down. It chronicles her struggles to piece together her life and her faith in God, in spite of the devastating circumstances.

In Reflections Of His Love, Miss Eareckson, who is also the author of two best-selling books, Joni and A Step Further, tells of the great transformations that have taken place in her life because of her willingness to accept all of the things that have happened to her.

A remarkably talented young woman, Miss Eareckson is an artist of great merit, as well as an author, actress, and singer. She has learned to draw and paint with a brush in her mouth. Her works have been displayed in major exhibitions, as well as on a number of network television programs. More recently, her illustrations and paintings have become the basis for a major line of greeting cards, plaques, and framed prints.

According to the Pastor Joseph Kyle of Milton Alliance Church, Reflections Of His Love introduces the viewer to "the real Joni Eareckson. We meet her parents, her sisters, and her friends. We gain insight into the thoughts of the actors who played major roles in the movie, Joni, and we learn of her new personal ministry, Joni and friends."

Pastor Kyle added that "the determination and the depth of trust and faith that his young lady has developed can serve as an inspiration to us all. Although she is a quadriplegic, and does not have the use of her legs or arms, we actually witness her drive a van in this film. It's much more than a great physical and technical feat—it's a credit to her inner spirit."

Pastor Kyle has extended an open invitation to the community at large to attend this special screening. There is no admission charge. "We feel everyone who attends will be touched by the

remarkable life and witness of Joni Eareckson. It's really an unforgettable experience," he concluded.

## THE CORPORATION OF THE TOWN OF MILTON 1982 MUNICIPAL, SCHOOL BOARDS AND HYDRO ELECTRIC COMMISSION ELECTIONS APPOINTMENT OF VOTING PROXY

Any person whose name is entered on the polling list for a polling subdivision or who has obtained a certificate entitling him to vote and who is:

(a) a person other than one who is in a hospital or other institution, where a polling place has been provided on such premises for the purpose of polling or where provision has been made to attend upon such persons for the purpose of receiving their ballot (Halton Centennial Manor); and

(b) a person who is certified by a legally qualified medical practitioner, by certificate filed with the Clerk Co-ordinator, to be physically incapable of attending a polling place;

(c) a person absent from his regular residence by reason of attending an educational institution and who is entered in the list for the polling subdivision in which he normally resides and who expects by reason of such absence to be unable to vote at the advance polls or on polling day; or

(d) a person who expects to be absent from his polling subdivision during the election period including the advance polls and polling day by reason of his being engaged for hire or reward in the business of transportation by railway, air, water or motor vehicle.

may vote by proxy in that polling subdivision.

Any person who is entitled to vote by proxy, above noted, may appoint in writing in the prescribed form, available at the Office of the Returning Officer, 251 Main Street East, Milton, as his voting proxy any other person who is eligible as an elector in the municipality.

Such persons must be appointed and certified by the Clerk Co-ordinator of Milton during the period following Nomination Day (October 19th, 1982 to 5:00 p.m. on Polling Day, November 8th, 1982).

### NAMES NOT ON POLLING LIST

Any person who has qualified to have his name entered on the polling list during the period of enumeration (September 7th, 1982 to September 30th, 1982) and finds that his name is not entered thereon or who has not filed the necessary forms to have his name entered during the period of corrections and additions to the list (ending October 20th, 1982) can attend the Returning Officer's Office to secure a certificate which will allow his name to be entered at the polling station.
