Books detail local history

Two volumes of Tweedsmuir Histories were deposited in the Milton Public Library on October 25.

The official presentation of these volumes, prepared by members of the Mountain Union Women's Institute, was made by Mrs. Ismey Bird, Halton District Women's Institute Tweedsmuir Curator to Mrs. Jenny Amy, Chief Librarian of Milton Library. Fifteen area members of the Women's Institute, including four life members attended the presentation held in the Local History Room at the Library.

The Tweedsmuir Histories are named after Lady Tweedsmuir, who suggested that the Women's Institutes should record their "village" histories, similar to those being done in England. (Lord Tweedsmuir was Governor General of Canada from 1935-

1940). Most institutes began to write their histories in the 1950's following suggestions produced in a manual published by the Federated Women's Institutes of Ontario. Six categories of materials were to be collected: the history of the Women's Institute itself; the history of the community; a record of postal and telephone services; the story of the land-tracing farm ownership from Crown grants; schools and churches; early community organizations. Such documents are a veritable goldmine of information for those interested in local history.

Milton Library was presented with five volumes of the histories from Mountain Union, Campbellville, and Drumquin in May this year.

EXPROPRIATIONS ACT

NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND

IN THE MATTER OF an application by her Majesty the Queen in right of Ontario as represented by the Minister of Government Services (expropriating authority) for approval to expropriate land being in the Town of Oakville, and partly in the Town of Milton, in the Regional Municipality of Halton, (formerly in the Township of Trafalgar, in the County of Halton) in the Province of Ontario for approval to expropriate land being for the purpose of acquiring land for Highway 403. - Westerly from 9th Line on behalf of the Minister of Transportation and Communications, pursuant to sub-section 7 (2) of the Ministry of Government Services Act, R.S.O. 1980, Chapter 279.

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the land described in Schedule "A" attached hereto. Any owner of lands in respect of which notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing.



NOTES:

The Expropriations Act provides that

where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Attorney General;

the inquiry officer,

shall give every party to the inquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally or by his counsel or agent, and

may recommend to the approving authority that a party to the inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200 and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.

"owner" and "registered owner" are defined in the Act as follows:

"owner includes a mortgage, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or of a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested.

"registered owner" means an owner of land whose interest in the

land is defined and whose name is specified in an instrument in the proper land registry or sheriff's office, and includes a person shown as a tenant of land on the last revised assessment roll.

The expropriating authority, each owner who notifies the approving authority that he desires a hearing in respect of the lands intended to be expropriated and any owner added as a party by the inquiry officer are parties to the inquiry.
