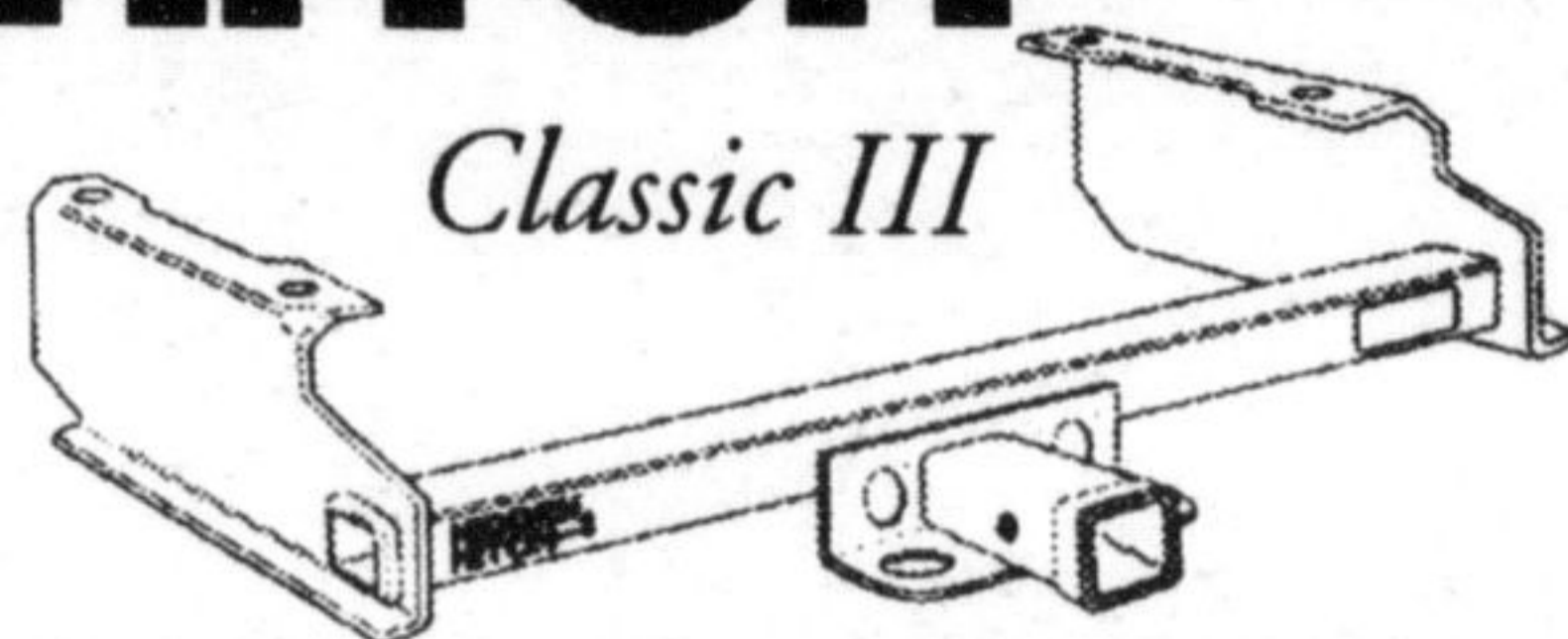

Don't hog parking spots

does not require the use of handicapped parking, but had come across "disrespectful" motorists when taking his late mother out to dinner.

"Getting a wheelchair out of a car requires some space, and it was annoying to me when vehicles without disabled certificates were parked in these spots," he recalled.

The tag system will have a two-pronged affect. Warning signs are expected to embarrass the offender - hopefully enough to prevent future incidents - as well as direct police to where offences are taking place. A copy of each warning will be submitted to Halton Regional Police, with stiff penalties available for repeat offenders.

Disabled program participants have been told to avoid confrontations with drivers wherever possible and to use discretion. Said Mr. Josie, "You don't go out to do this on purpose. I haven't had to use a warning sign yet and I hope this continues."

"Of course part of the reason for this is because Milton has plenty of free parking and by and large people here are more courteous than in larger cities."

In addition to a partnership with Halton Regional Police, the program is supported by eight regional agencies. Many business owners have also expressed interest in handing out warning signs to violators in their immediate district.

"As far as I know, Halton is the first area to introduce such a program. I think it's a good idea. We need to look after these (disabled) people, who in many cases can't protect themselves," Mr. Josie said.

Notice is hereby given to all persons in possession of land, in accordance with The Weed Control Act, R.S.O. 1990, Chapter W.5, Sections 3, 13, 14, 16 and 23 that, unless weed seeds and noxious weeds growing on their lands within the Town of Milton are destroyed by the date of June 15th, 1997 and throughout the season, the Town of Milton may enter upon the said lands and have the weeds destroyed, charging the costs against the land in taxes as set out in The Weed Control Act.

The co-operation of all property owners is earnestly solicited. Complaints and inquiries may be made by telephone, to the number listed below. Please note that dandelions, burdock and goldenrod are not considered noxious weeds within the Town of Milton under The Weed Control Act; therefore, complaints concerning these weeds or any anonymous complaints cannot be accepted.
