Dump may get T.O. waste

Halton could soon be taking Toronto's garbage.

The Greater Toronto Services Board (GTSB) report released Wednesday by Milt Farrow acknowledges the need to plan for landfills in an overall strategy. However, nowhere in the text does Mr. Farrow exclude the Halton landfill from use by the GTSB.

Halton officials seemed stunned by what they saw as an oversight.

ment to create a framework for coordination of major services like water, sewers, GO Transit, roads and waste management.

According to Halton Chair Joyce Savoline, Mr. Farrow provided assurances that Halton's landfill would be protected from use by other municipalities. Currently it is the only licensed landfill site in the Greater Toronto Area (GTA).

"He made the statement to exclude the Halton landfill site," said Ms Savoline. "He said its size was insignificant in terms of greater Toronto's total need."

Ms Savoline said Mr. Farrow's failure to put the exclusion in the report must simply be an oversight. She said she would investigate immediately.

The report was released by Al Leach, the minister of municipal affairs, who asked for comments to be forwarded to his office.

"The problem with garbage is bigger than Halton can handle," Ms Savoline said. "So why fix one problem by creating another? It doesn't make any common sense.'

Mr. Farrow was charged by the provincial governe exclusively by population. Halton officials had said that land area should be considered to balance out urban and rural needs. Mr. Farrow calls for a 28-member board with Toronto getting 14 representatives and Halton receiving two. Durham would get three, York four and Peel five.

Ms. Savoline said she had impressed upon Mr. Farrow that with Halton's significant urban-rural split the Regional Chair and one other representative are not enough.

"To leave one type of municipality out is grossly unfair," she said.

Mr. Farrow also recommended that the GTSB operate GO Transit. He reinforced his position on representation by population in suggesting that three representatives from Hamilton-Wentworth be present for GO Transit discussions, while Halton would get only two. Halton has six GO stations to Hamilton-Wentworth's one.
