swing one-handed," said Villeneuve, who uses a specially designed brace to steady her left arm during play. "I still have chronic pains sometimes, but it hurts a lot more to sit at home doing nothing than it does to drive the ball."

The local golfer said recent lessons with Simpson have raised her self-esteem and rejuvenated her love for the game.

"It's fantastic what he's doing to help the disabled get involved in golf. It won't be long before I'm out on the course playing with my friends.

"I sat at home for a long time but now I'm the first one out there."

Simpson empathizes with disabled athletes who face

major restrictions in competition. Twenty-six years ago the golf pro went temporarily blind as a result of diabetes and was unable to play.

His disabled golfers program began last summer with nephew Ryan Leworthy acting as his first student.

"I know what it's like to face a disability, and I want to give all people a chance to golf," he said.

The Ultimate Golf Challenge, which runs from 10 a.m. to 1 p.m., will include blind and wheelchair participants as well as Special Olympic athletes.

Co-sponsoring the Canadian Disabled Golfer's Association are the Canadian Professional Golfer's Association (CPGA) and the Ontario Golfer's Association (OGA).


