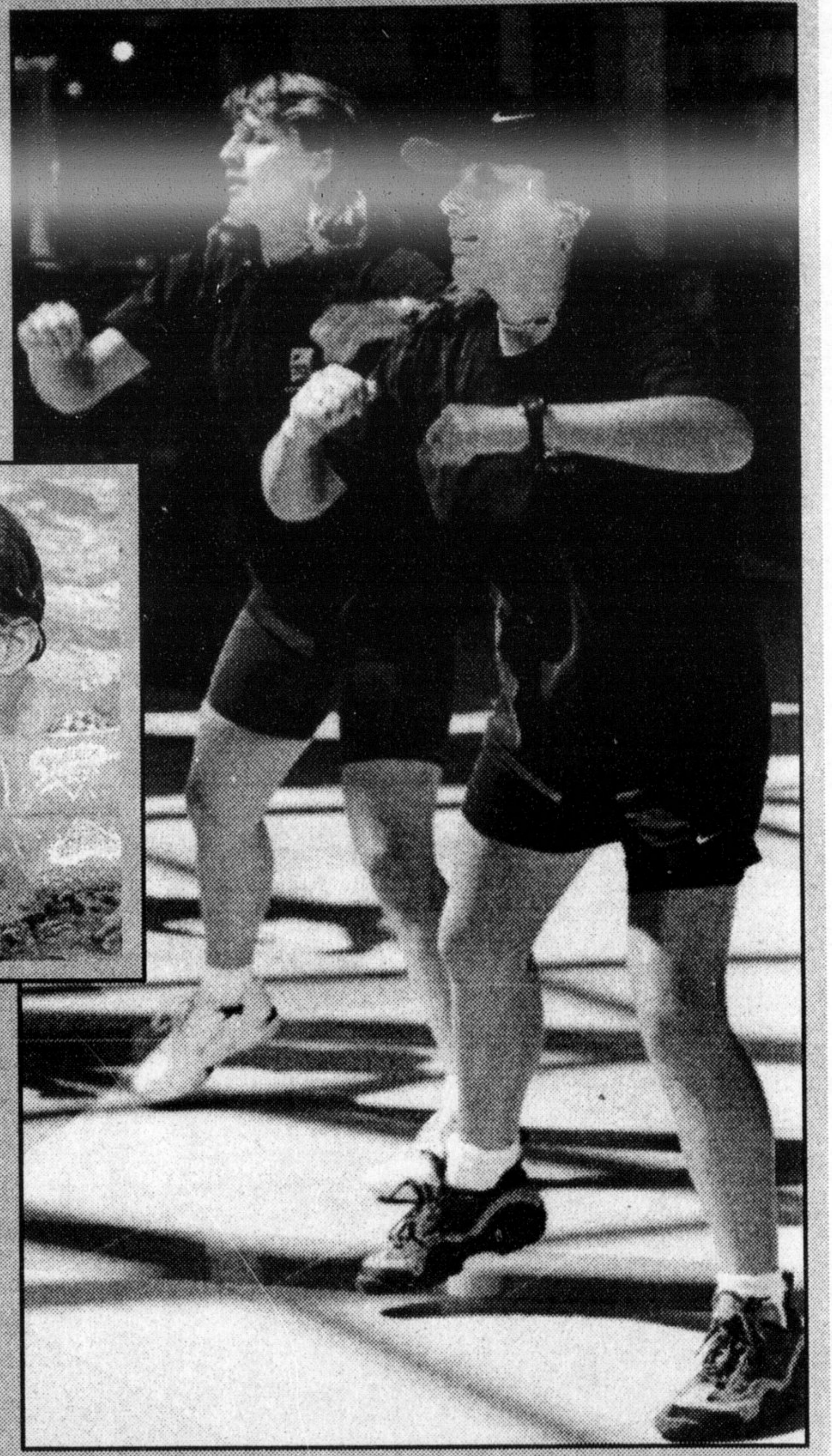

**NOTICE OF THE PASSING OF A ZONING BY-LAW BY THE CORPORATION OF THE CITY OF MISSISSAUGA**

**By-Law 427-97**

TAKE NOTICE that the Council of The Corporation of the City of Mississauga passed By-law 427-97 on the 10th day of September, 1997, under Section 34 of the Planning Act, R.S.O., 1990, c.P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-law by filing with the Clerk of the City of Mississauga not later than the **7th day of October, 1997**, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, together with a cheque in the amount of \$125.00 payable to the Minister of Finance.

Only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

**EXPLANATION OF THE PURPOSE AND EFFECT OF THE BY-LAW**

This By-law amends a number of provisions under Zoning Bylaw 5500 including replacing the words "Bank/Trust Company" with "Bank Financial Institution/Money Lending Agency" in the schedule for Parking and Loading Standards for Non-Residential Uses; the deletion of a provision prohibiting vertical propane tank storage; the deletion of a redundant provision regarding maximum driveway width in an "RM1" Zone; the addition of certain uses under the Established Commercial "EC" Zone, the District Commercial "DC" Zone, the Highway Commercial "HC" Zone, the Restricted Commercial "RC" Zone, and the General Provisions for Industrial Uses; and the exclusion of accessory sales and display of motor vehicles under the General Provisions for Industrial uses.

This By-law amends a number of provisions under Port Credit Zoning By-law 1227 including the deletion of a provision prohibiting vertical propane tank storage; the addition of certain uses under the "C1", "C2", "C3", "C4", and "C5" (Commercial Zones); and replacing the words "Bank/Trust Company" with "Bank/Financial institution/Money Lending Agency" in the schedule for Parking and Loading Standards for Non-Residential Uses.

All lands in the City of Mississauga (former Town of Port Credit) affected by By-law 1227.

**EXPLANATION OF THE PURPOSE AND EFFECT OF THE BY-LAW**

This By-law amends a number of provisions under Streetsville Zoning By-law 65-30 including replacing the words "BUSINESS OR PROFESSIONAL OFFICE" with "BUSINESS, PROFESSIONAL OR ADMINISTRATIVE OFFICE" in the Definitions section; replacing the words "RESTAURANTS/ EATING ESTABLISHMENT" with "RESTAURANT" in the Definitions section; replacing the words "Bank/Trust Company" with "Bank/Financial Institution/Money Lending Agency" in the schedule for Parking and Loading Standards; the addition of a definition of "Convenience Store"; the deletion of the words "eating establishment" from a general provision regarding setback of restaurants from a residential zone; the deletion of a provision prohibiting vertical propane tank storage; and the addition of certain uses under the Restricted Commercial ("C1") Zone, the Shopping Centre Commercial ("C2") Zone, the Highway Commercial ("HC") Zone, and the Light Industrial ("M1") Zone.

All lands in the City of Mississauga (former Town of Streetsville) affected by By-law 65-30.

**Money for rail crossing**

Safety at the Steeles Avenue railway crossing will be improved following a federal government grant for \$87,800.

Halton MP Julian Reed announced Tuesday that Transport Canada will finance up to 80 per cent of the cost of the improvements.

The balance of the funding for the cross-Canada initiative will be provided by the railways, municipalities or provinces.

An automated warning system will be installed at the Steeles Avenue crossing, just east of Tremaine Road and west of Peru Road (formerly First Line).

A flashing light and bell warning system will signal the approach of a train.

Mr. Reed said the improvements — part of a national program to enhance safety at 36 crossings across Canada — "will go a long way toward protecting the public."

He said accidents at crossings account for half of railway-related deaths and injuries each year.

There were 342 crossing accidents in Canada during 1996 and 184 from January to July, 1997.

Of the 1997 accidents, 20 were fatalities. — 11 of which took place at protected crossings equipped with automated signals. Eight were at unprotected crossings (only signs posted) and one was at a private crossing.
