

Will You Regional chair is running again

Joyce Savoline is on the campaign trail. While most candidates can only try to speak with as many voters as possible, Ms Savoline, the current Chair of Halton

Region, can talk to all of them easily. There are only 20.

In Halton Region the chair is elected by those people who win seats on council. The new regional council will have 20 members, seven each from Burlington and Oakville, and three each from Milton and Halton Hills.

Ms Savoline was elected to the chair's position three years ago, replacing Peter Pomeroy. She had been a regional councillor from Burlington for several terms prior

There have been no indications that anyone will run against her. While elected regional councillors are usually the only people to contest the position, any eligible Halton voter can put their name forward for the job.

Councillors are scheduled to cast ballots Wednesday, Dec. 10 for the position, which pays approximately \$70,000 per

"I'm trying now to understand the expectations and goals of all members of council," she said. "My goal is to make sure council is unified against provincial downloading."

Ms Savoline said most members of the new council have municipal experience and are familiar with the downloading

"People coming in are passionate and know their community needs," she said. During the last term, council voted against making the chair's position one elected at large by Halton voters.

The issue played out and a vote was taken with two councillors missing from the chambers. It ended tied. Ms Savoline refused to break the tie, insisting that the vote be postponed until all councillors were available.

When the full council was present they decided by a narrow majority to maintain the status quo and keep the voting responsibility for chair with council.
