

Stars shine at Sheridan

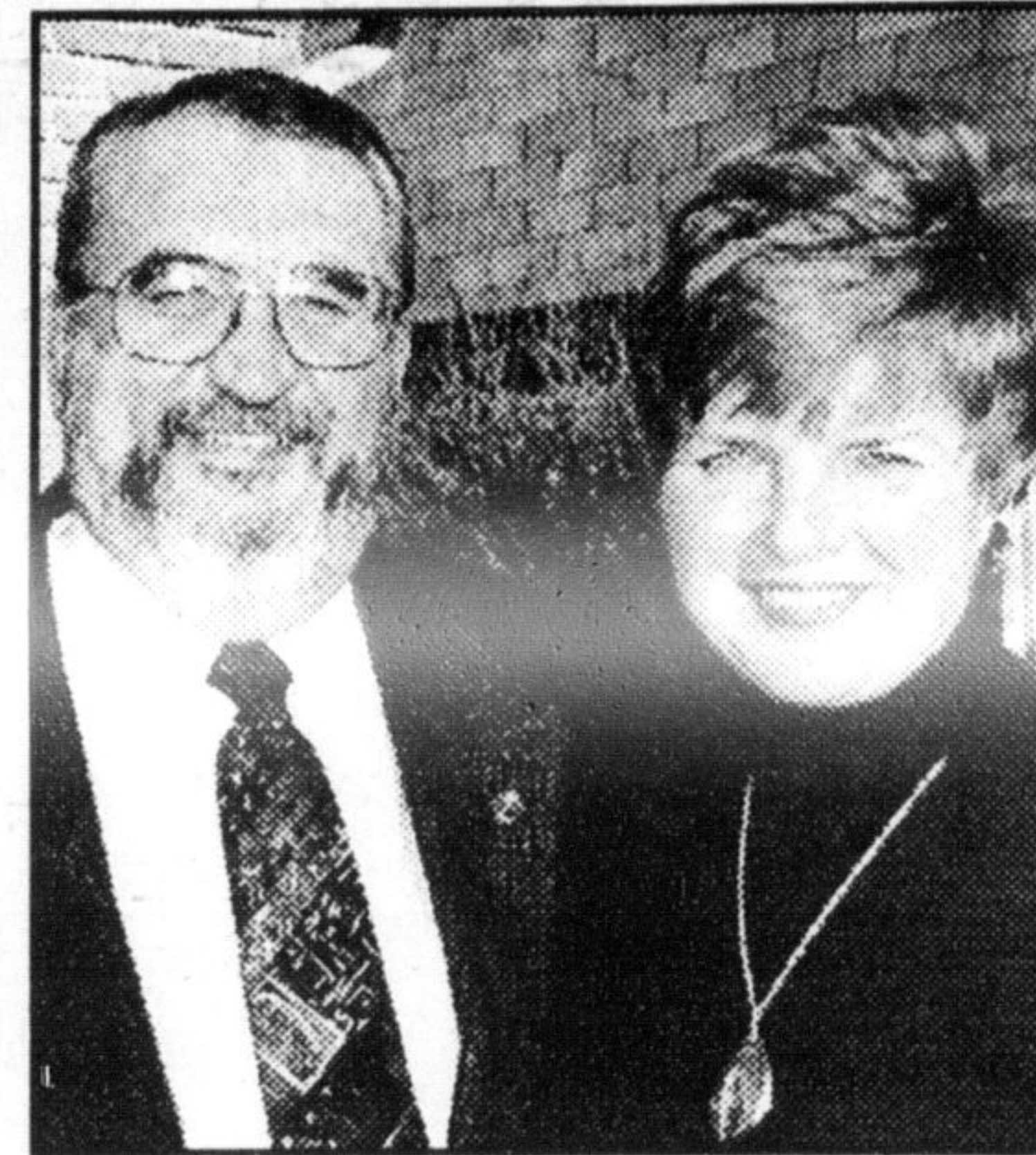

Citizen nominees honoured

Generous, selfless, committed, dedicated. Any and all of these virtues can be used to describe any and all of this year's Milton Chamber of Commerce Citizen of the Year nominees.

Throw in teamwork and you've got Judy and Bob Wallace, who could become the first couple to win the coveted award.

Married 27 years, they've co-chaired the United Way fundraising campaign the last two years — which have been the two most successful in the local chapter's history with a whopping \$237,000 and \$240,000 in annual donations.

"I'd say our time with the United Way has been the most satisfying (of all our volunteer work)," said Mr. Wallace. "We've had our own separate projects over the years, but mostly we've tried to find interests we could share, which has been nice."

Described as 'model citizens' by their nominator, the Wallaces have held various other positions with the United Way. Before that, they spent years volunteering with the Boy Scouts of Canada, while Ms Wallace also donated her time at the elementary school level.

She said news of their nomination came as an incredible surprise, adding "I didn't believe it when Ries Boers told me so I joked along with him until the seriousness of it started sinking in."

"What a high. You don't expect people to remember all the work you've done over the years, but I guess they do."

Also up for Citizen of the Year is another United Way heavyweight, Brad Clements.

Writes his nominator, "After leaving politics, many would disappear into the woodwork. Brad did not. He maintained a heavy involvement with organizations including the Steam (Era) Show and Milton Community and Information Services."

"His experience and wisdom have successfully kept many projects on track in difficult times."

In recent years, the former town and regional councillor has aggressively campaigned in support of the United Way. He's also had a hand in the Antique Preservers Association, Christmas Tree Growers Association of Ontario, Milton Historical Society and helped form the new Milton Community Resource Centre.

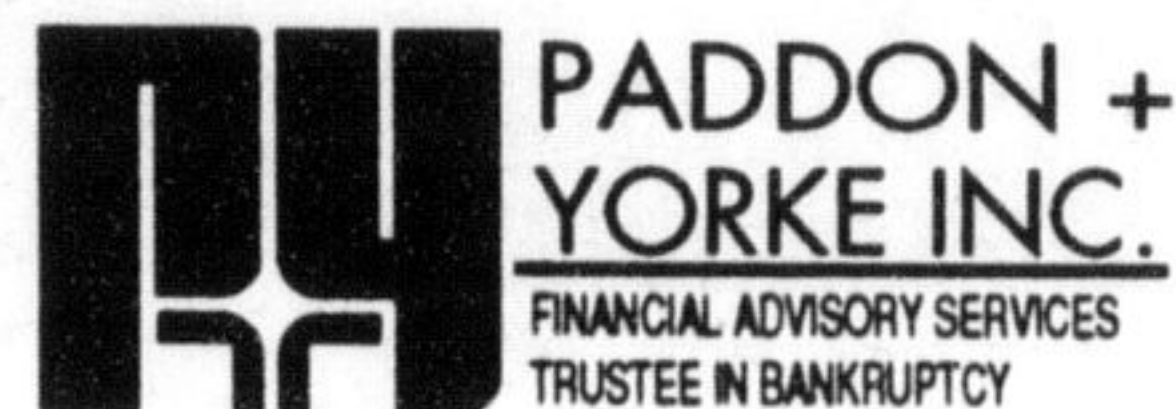

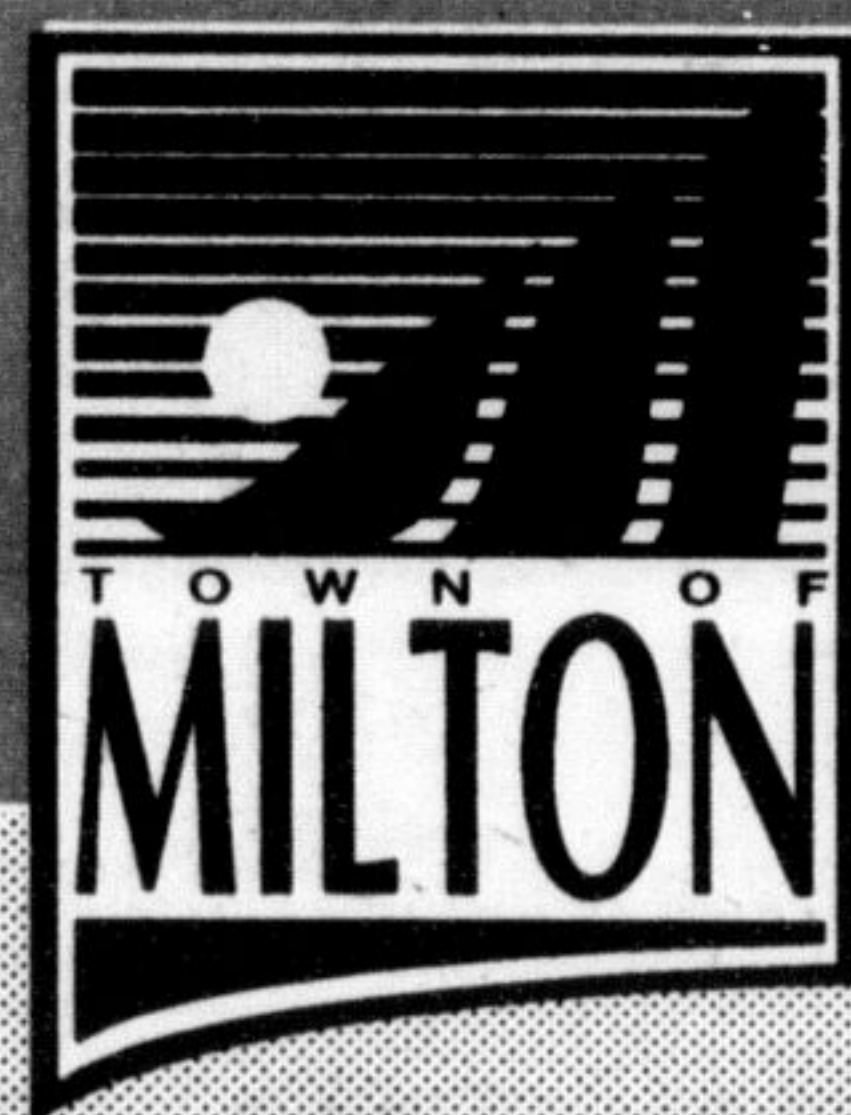

REASONS FOR THE PROPOSED DESIGNATION:

Elliott House is of both historical and architectural significance. The Context is not included in the reasons for designation as major changes to this context have occurred. The primary reasons for its architectural significance are that the house dates back to 1840, is an excellent example of a gothic red-brick farmhouse, which is in excellent condition today. The structure has retained features such as a bell tower, gable roof, gingerbread trim and thin segmented bay windows. The home was in the Elliott family from 1833 to 1955. The 1877 Atlas of Halton County indicates that the home was situated on a 100 acre parcel, with an additional ownership of 250 acres in Lots 1 and 2 of Concession 3, to the west and south of the subject property. The occupation of both William Sr. and Jr. was of farmer. These lands now form a large part of the industrial area adjacent to the 401 and also houses the Maplehurst facility.

REASONS FOR THE PROPOSED DESIGNATION:

This building, constructed in 1856, is a two storey terrace house on a raised basement which comprises the west half of a two unit building. It is Georgian in style with a 3 bay front elevation. The entrance consists of a panelled door with rectangular transom and sidelights. All windows are double hung with six lites in each sash. The front and side elevations are finished using ashlar limestone blocks with tooled faces, laid in a coursed, broken-bond pattern. The south-west corner of the building is set off with bevelled limestone quoins and all openings are spanned with simple limestone lintels. The home, one of the first semi-detached homes in Milton, was constructed by Edward Martin, son of Jasper Martin, and was rented. It was the residence of G.T. Bastedo, a lawyer and the first appointed Clerk of the peace and County Attorney for Halton.

Municipal Address:
Christie-Henderson Lime Kilns, Milton, Ontario (Part of Lot 4, Concession 6, Nassagaweya)

REASONS FOR THE PROPOSED DESIGNATION:

The three lime kilns located on the escarpment are one of the few remaining examples of this industry left in Ontario. These "draw" kilns were constructed by the Christie-Henderson families who were settlers in the region since 1830. The first kiln was constructed in 1880, the remaining two followed in 1903 and 1910. Despite their age and deterioration due to weather and vandalism, they are still an excellent example of pioneer technology for the production of lime, an industry that had a major impact on the surrounding community. Built from local stone, the east and west kilns remain almost to their original height. The south unfortunately has suffered severe damage. The Halton Region Conservation Authority, owner of the property, has taken steps to protect the kilns and, with designation, new interest can be raised for the site. The quarry and kiln area remain much as they were during the last days of operation. Artifacts, tailings, limestone, dynamite holes and other parts of the operation are still visible. The present condition and location of the Christie-Henderson Lime Kilns make them an ideal reminder of the little known aspects concerning the history of this once thriving industry. Designation of these kilns would be a worthwhile contribution in helping to preserve them for the education of future generations. Designation would recognize an important memento of our Canadian heritage.

TAX NOTICE

Ratepayers of the Town of Milton are reminded that the first instalment of the 1998 Interim Tax Bill is due on March 5, 1998

If you require information about taxes, please contact the Corporate Services Tax Department at 878-7211, 8:30 am to 4:30 pm, Monday to Friday.

Tax payments must be received in the Corporate Services Office on or before the due date to avoid penalty. Late payment charge of 1 1/4% will be charged on the first day of default and on the first day of each calendar month in which the default continues. It is the responsibility of the ratepayer to ensure that the taxes are paid by the due date, even in the event that the bill is not received as mailed.

- Taxes may be paid:
- By mail to the Corporate Services Tax Department, 43 Brown St., Milton ON L9T 5H2. Cheques post dated to the due date are acceptable and encouraged.
 - At the Canadian Imperial Bank of Commerce, Main St. Milton (there is a small service charge)
 - By the phone if you bank with Canada Trust, TD Bank, CIBC, Royal Bank or Bank of Montreal. Please call them for details.
 - By using the mail deposit box to the left of the glass doors at Town Hall.
 - Between the hours of 8:30 am and 4:30 pm at the Corporate Services Tax Department, Town Hall, 43 Brown St., Milton. (cheque or money orders preferred rather than cash).
