"I don't understand what you're asking me," Mr. Gagnon repeated frequently, before finally saying "It wasn't just Pearl going out and spending money. Susan might have said something about unnecessary spending but that would be up to Fred."

"Was there any reason that was hard to get out of you, sir?" said an exasperated-sounding Mr. Derstine.

Mr. Gagnon also testified that he had not seen or heard of any will leaving much of note to Ms Johnston.

The defense began it's case Wednesday by casting doubt on the date of Mr. Sheppard's death with a series of witnesses claiming to have seen him driving his old light brown Hornet in Milton between March 5 and 7 1995.

Court has been told the death occurred between March 1 and 7, 1995.

Richard Cargill told court he saw the victim driving in Milton just two days before being informed of his death.

"I was going north on Bronte (Street) and he was going south. We passed each other right over the tracks. He had his dogs in the car, as always," said Mr. Cargill.

Mr. Sheppard owned five Pomeranian dogs and court has heard he always took two or three of them with him when he went out.

"I know it was either Monday or Tuesday (March 6 or 7) because I picked up my wife from work to go to my mother's for lunch," he recalled.

"I was extra shocked when I found out he was dead because I said 'Oh my God, I just saw him a couple of days ago."

Ron Newell, a friend of Mr. Sheppard's for 40 years, told the jury he saw Mr. Sheppard driving on Sunday Mar. 5.

"I seen (sic) him around Bronte Street at about 2 p.m. on the first Sunday in March, near Steeles (Avenue)," Mr. Newell told the court. "He was driving north on Bronte and I was driving south."

At press time, Pearl Johnston was scheduled to testify yesterday (Thursday).
