In December 1997, Lower Base Line between Fifth and Sixth Line was closed by the Town of Milton. This was due to a decreased slope stability caused by the low flow channel of the creek eroding the valley slope toe. In turn, the receding valley slope toe increased the potential for slope failure.

To address this problem, The Town of Milton is undertaking a feasibility study to assess the impact of various options being considered for reopening the roadway. the project is being planned under Schedule B of the Class Environmental Assessment for Municipal Water and Wastewater projects. A public Information Centre has been scheduled to provide an opportunity for the public and landowners to review the various options, provide input and to discuss the project with the Town staff and consultants.

Serjeantson dismisses linking with Milton

Milton and Halton Hills should attempt to share resources but formal amalgamation of the two municipalities is going too far, says Halton Hills Mayor Marilyn Serjeantson.

In that light, the second term mayor said Halton Hills council would consider sharing their existing chief administrative officer and director of public works with Milton.

Those positions and town clerk are currently vacant in Milton.

"If it makes good financial sense we would consider sharing the CAO and (director of public works)," said Ms Serjeantson.

"It is premature to have any talk of amalgamation, but any ways to work together to streamline operations should be attempted."

Making Halton one single city is an even more remote possibility than amalgamation, she says, but it could happen in the future.

"It takes as long to get to Oakville from here as it does to get to Richmond Hill," said Ms Serjeantson to highlight a lack of shared interest between most Halton Hills residents and Oakville.

She explained that being on the fringe of Halton, on the fringe of the Greater Toronto Area, and on the fringe of the new hospital organization has its advantages.

Georgetown hospital used to have an annual budget of \$17 mil-

lion but is now part of an organization with a \$176 million annual budget, she said.

The Halton Hills mayor brought the amalgamation issue to her council for a discussion in June, citing Burlington Mayor Rob MacIsaac's proposal to amalgamate his municipality with Milton and Flamborough.

There was no formal council motion on the issue, just an open discussion.

Like Milton Mayor Gord Krantz, Ms Serjeantson is unwilling to discuss the issue without formal council approval.

Milton council brushed off Mr. MacIsaac's attempt to initiate talks, citing higher priorities.

According to Ms Serjeantson, Halton Hills council is generally against amalgamation with Milton.

"This goes back to 1973 and the creation of regional government," she said.
