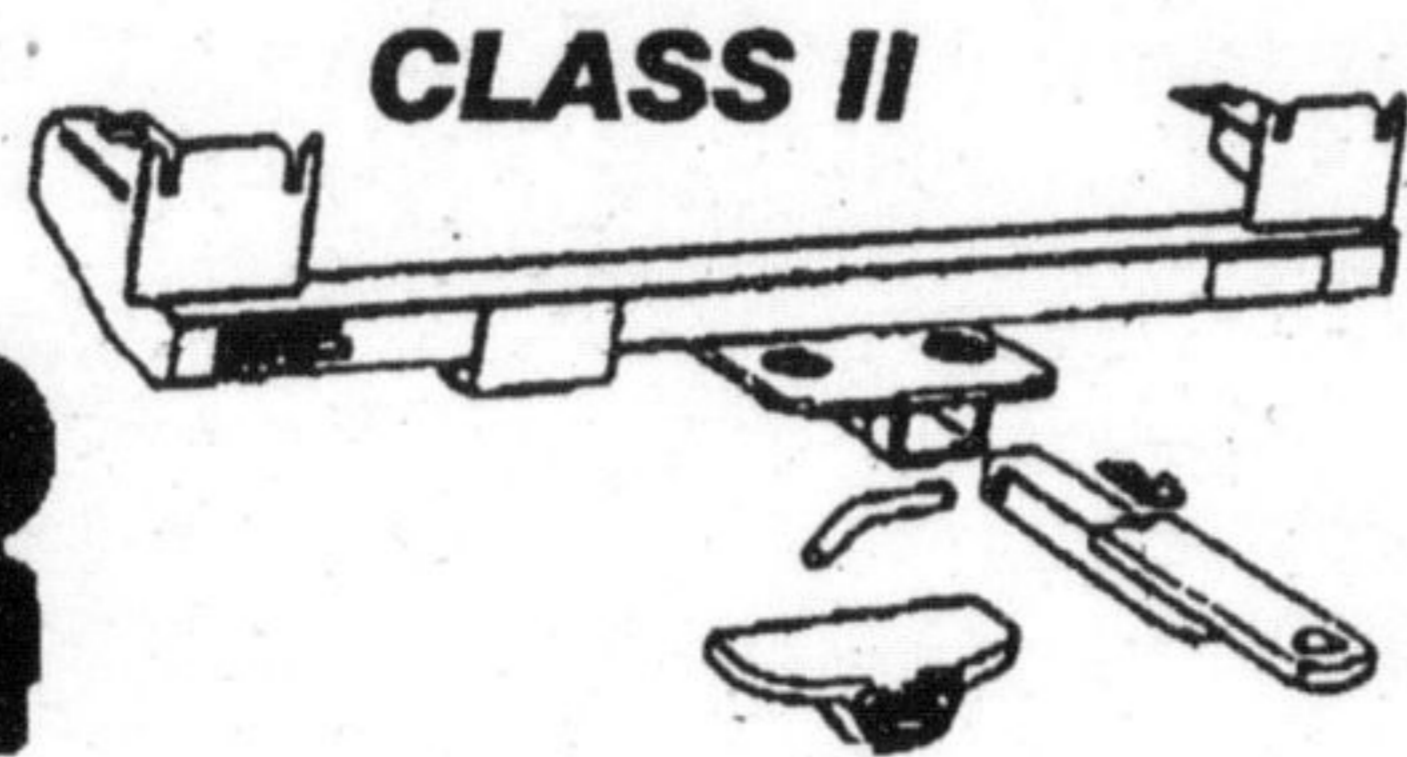


Indian summer festival

Milton's Derron Bain is currently touring the country with the 1998 Naval Gun Run, which offers a unique look at part of Canada's military history.

Bain commands naval show

Milton's Derron Bain is the officer in charge of the 1998 Naval Gun Run, a demonstration of a unique part of Canada's military history.

The Gun Run team tours the country displaying the ability of 19th century sailors to tear down a naval artillery piece, move it from ship to shore and put it back in working order for military action.

The cannon and carriage used in the show weigh in at 1,800 kilograms or nearly 4,000 pounds.

The crew of 35 sailors move the piece over obstacles to simulate hills and cliffs, reassemble it, fire the cannon, then disassemble it and return it to its original location and status.

"It's a lot of fun for the team. Most of them are from ships stationed in Halifax. This gives them a break," said Sub-Lieutenant Bain. "The navy gets interaction with the public. People want to know how much train-

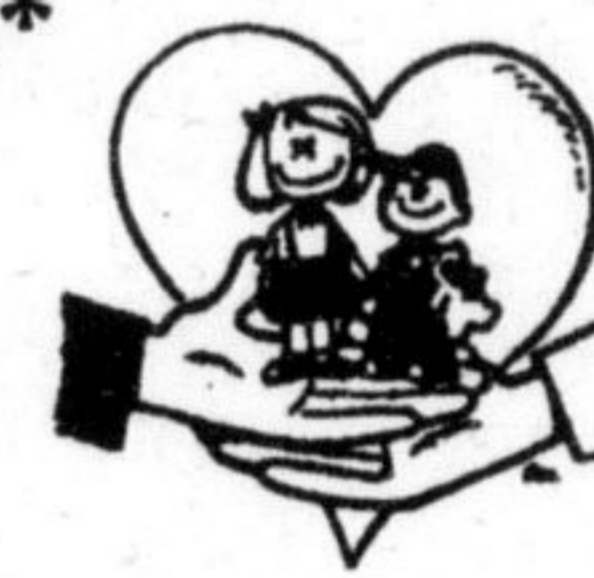

IMPORTANT PROPERTY TAX INFORMATION

Tax due dates for the Town of Milton are **September 30, 1998 and October 30, 1998.**
Tax bills will be mailed on or before September 09, 1998.

Major changes imposed by the Government of Ontario have substantially changed the way in which properties are assessed and taxed for 1998. These changes will affect all Milton property taxpayers in some way. Previously, property taxes payable were calculated using mill rates (commercial/industrial and residential). Under the new system, mill rates have been replaced by tax rates. The tax rate is multiplied by the CVA (current value assessment) of the property as of June 30, 1996 as supplied to the property owner by the Regional Assessment Office.

PROPERTY CLASS	RURAL RATE	URBAN RATE	To calculate your 98 Taxes:
Residential/Farm	1.272454%	1.390797%	Multiply your CVA by the tax rate listed on the table. Examples: *Residence with CVA of \$175,000 * 1.390797% = \$2,433.89 *Commercial with CVA of \$200,000 * 3.462851% = \$6,925.70

A complete tax information brochure will be mailed to all property owners with the tax bills. Included in this will be a full table listing all subclasses of above property classes and we encourage you to read this document fully. The property tax bills will be mailed to property owners the first week of September.
