



ocal lass Colleen Feddery is so eager to prevent the razing of the Costa Rican rain forest she's willing to razor her own head for the

Ms Feddery, 19, hopes to make her personal debut at the rain forest in December as part of Youth Challenge International (YCI.)

Ms Feddery will spend three weeks in the rain forest and nine weeks helping out a Costa Rican community.

First, though, she's required to raise \$4,000, which is pretty much where the razor comes in to play.

Bald is beautiful

"A teacher at my old high school put a challenge to the school that if they raised \$500 he would shave his head," said Ms Feddery. In fact the school, Trinity College in Port Hope, raised more than \$600, and the teacher in question went bald.

Since then, Ms Feddery figured that worked so well for him, she could try it herself.

"I just want people to know that if they can raise a large amount of money I'd be willing to shave my own head," said Ms Feddery.

She is also willing to do slightly less intrepid things, such as the Saturday, Oct. 3 barbecue scheduled to take place from 10 a.m. to 4 p.m. at the new Loblaws at Main Street and Nipissing Road.

She also plans to contact service groups and local businesses for donations, a plan that has already netted her more than \$2,000.

As part of YCI, Ms Feddery is expected to live up to four conditions, the first of which was to simply be accepted. That, she explained, wasn't as simple as it may

NOTICE OF COMPLETION OF STUDY

In December 1997, Lower Base Line Road between Fifth and Sixth Line was closed due to a decreased slope stability caused by the creek eroding the receding valley slope toe. To address this problem, the Town has completed a study following the Environmental Assessment process. The preferred option, adopted by Council is 2A which requires a minor realignment of Lower Base Line, installation of a surface drainage system and erosion protection along the valley slope toe
