### Obstetrics closure affects whole community

Dear Editor:

It is with great concern that I write you this letter. The recent closing of the obstetrics unit at Milton District Hospital has affected the entire community. As a first-time pregnant woman, I, quite naturally, have many things to worry about. Being able to use my local hospital should not be one of them.

cannot believe that I live in a town that places a higher value on criminals than it does its citizens. I watch daily as we spend millions of dollars to build a new super jail — just so we can have the distinction of having the largest jail in Canada complete with both male and female prisoners, all of who will have the privilege of using our local hospital.

Meanwhile, I, a law-abiding, tax-paying citizen of Milton, have to make arrangements to go to another hospital to have my baby. What's wrong with this picture? Will the dangerous inmates get priority in the emergency department so they don't have to wait with the poor public?

My family physician has suggested that I go to Oakville-Trafalgar Memorial Hospital for my delivery.

Based on other experiences there, along with the coverage given in the Canadian Champion, I have refused. I know of women who were sent home while they were in labour because "they were too busy" and

didn't have enough beds. If I have to drive 45 minutes to get to the hospital while I am in labour, I cannot take the chance that they will send me home. I also know of women who delivered late in the evening and were sent home the next morning, less than 12 hours later. This is not the childbirth experience I want to

The Oakville doctors have understandably refused to work at both sites because they are already working 80 to 120 hours per week. I fail to understand how adding 350 extra deliveries to the 2,200 already done in Oakville annually is considered a solution.

When I read Dr. Walter Koslowski's letter in The Champion, saying that an obstetrician had been found, but the board of directors found the salary expectations were too high, it made we wonder how hard they are actually trying to resolve this.

I also read the full page advertisement in the local paper and called the number that promised more answers and a return phone call as soon as possible. It has been weeks and I still haven't heard back.

I have now chosen to go to Joseph Brant Hospital in Burlington for delivery, but I still hold out hope that over the next four months, an obstetrician will be found and I can have my baby in my home town.
